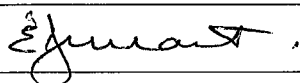

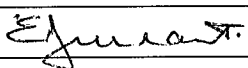

This year has seen the shop trading well with the volunteers actively researching and implementing good retail practices, cost control and analysis of what sells well.

The implementation of the card machine is working well and the trustees are investigating a way to use tokens for the coffee machine to reduce the amount of cash needed for the shop, thereby alleviating the issue of being charged for depositing and not having a local branch to deposit in.

We have responded to requested for funding from the Trust, including wheelchairs and specialist play equipment for children who struggle with conventional medical hospital visits.

A plaque is being arranged to commemorate a valued trustee and colleague of the hospital, to be installed soon, actively advertising the work of this League of Friends.

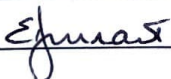

Footfall in the shop has increased as the hospital has got busier and this, together with the introduction of card payments, has resulted in a significant increase in takings as fewer and fewer customers are using cash post Covid.

The shop has introduced snack options which has proved popular with both patients having a lengthy wait and staff.

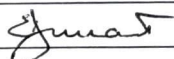
