**Activities:** WORKING TO PROMOTE A SENSE OF COMMUNITY IN THE NEIGHBOURHOOD BY BRINGING TOGETHER THE INHABITANTS, LOCAL AUTHORITIES AND VOLUNTARY ASSOCIATIONS IN COMMON ACCORD. INVOLVED IN THE PRESERVATION, DEVELOPMENT AND IMPROVEMENT FOR PUBLIC BENEFIT OF THE CHARACTER AND AMENITIES OF THE NEIGHBOURHOOD.
