(4) ANY REMAINING PART OF THE SAID INCOME NOT REQUIRED FOR APPLICATION IN MANNER AFORESAID SHALL BE APPLIED BY THE TRUSTEES IN FURTHERING THE RELIGIOUS AND OTHER CHARITABLE WORK OF THE CHURCH OF ENGLAND IN THE AREA OF BENEFIT.

# **St Leonards Church Trust**

## **Annual Report of the Trustees for the year ended 31st December 2022**

### **Constitution of the Trust**

St Leonards Church Trust is a registered charity (No.288728) and grant making Trust with a permanent Endowment Fund. It is regulated by the terms of a Scheme of the Charity Commission dated 20th September 1995. This states that the Trustees shall apply the annual income as follows:

- (1) One sixteenth for any charitable purpose for the general benefit of the inhabitants of the area of benefit (referred to in this report and the attached accounts as Public Purposes Fund).
- (2) As to seven-sixteenths in or towards the maintenance and repair of the fabric of St Leonards Church and its churchyard and other property and in establishing and maintaining an Extraordinary Repair Fund.
- (3) As to eight-sixteenths the Trustees may apply such part as they from time to time think fit in or towards the payment of expenses incurred by the Incumbent of St Leonards and subject thereto in defraying the expenses of maintaining services at St Leonards Church.
- (4) Any remaining part of the above income not required for application in accordance with the above shall be applied by the Trustees in furthering the religious and other charitable work of the Church of England in the area of benefit.

### **Area of Benefit**

The area of benefit is the Ecclesiastical Parish of St Leonard, St Leonards

### **Trustees and Trust Secretary**

Under the constitution there shall be a minimum of five and a maximum of nine trustees all of whom must live or work in or near the area of benefit.

Trustees are appointed for a term of eight years by resolution of the Trustees. Those who acted during the year and their respective dates for termination of office are as follow:

Paula Angell (21 September 2028), Richard Baddon (28 May 2027), Jonathan Bright (21 September 2028), Nick Butterworth (28 May 2027), Katharine Dallas (1 June 2027), Michael Joseph (30 May 2025), Gunnar Maintzer (23 May 2030), Christopher Matthews (5 October 2029) and Giles Pemberton (4 October 2030).

The Trust Secretary is Nick Butterworth

### **Review of the year – General Fund**

The Trust's General Fund income for the year ended 31st December 2022 amounted to £5,441 (2021: £5,289) and the Trustees determined that this should be applied by transferring £340 (2021: £331) to the Public Purposes Fund, transferring £2,381 (2021: £2,314) to the Extraordinary Repair Fund and by making a grant to St Leonards PCC of £2,720 (2021: £2,644) towards the expenses of holding services at St Leonards Church.

### **Review of the year – Extraordinary Repair Fund**

The Trustees approved a grant from the Fund to St Leonards PCC during the year amounting to £1,045 for the repair and extension of the Church's sound system. At 31 December 2022 the balance on the Fund was £35,716 (2021: £37,113).

### **Review of the year – Public Purposes Fund**

At the 31 December 2022 the balance on the Fund was £3,454 (2021: £3,086).

### **G Oldham Gift Fund**

During the year the Trustees received a gift of £100,254 from Gavin Oldham. In his letter of offer he requested that the Trustees apply the gift and the income arising from it in any way they decide at their absolute discretion for the benefit of St Leonards Church and Christian mission, ministry and worship in the parish.

On receipt this sum was deposited with COIF Charities Deposit Fund and subsequently £50,000 of it was invested in COIF Charities Investment Fund – Income Units

The Trustees determined that it was a Restricted Fund falling within the provisions of the Trust Deed and it will be applied for the following purposes:-

- (i) repairs to St Leonards Church fabric
- (ii) the cost of holding services in St Leonards
- (iii) furthering the religious and other charitable work of the Church of England in the Parish of St Leonards

At the 31 December 2022 the balance on the Fund was £100,062.

## **Independent Examiner's Report to the Trustees of St Leonards Church Trust**

I report on the accounts for the year ended 31st December 2022 which are set out on pages 3 to 6.

### **Respective responsibilities of the Trustees and Independent Examiner**

The charity's Trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.
