Annual Report of the League of Friends of Moreton District
(North Cotswolds) Hospital

October 23rd 2023 Held in the conference room at NCH

The full name of the Charity is The League of Friends of Moreton District (North Cotswolds) Hospital and the registered charity number is 288816.

The Governing Instrument of the Charity is the Constitution adopted on the 18th August 1956.

The objects of The League of Friends are to mobilize, encourage, foster and maintain the interest of the public in the patients and support the work of the Moreton-in-Marsh District Hospital by means of voluntary service; to provide funds for the purpose either of supplementing in such manner as the League thinks fit the resources of the hospital service or of putting such funds or any part thereof at the disposal of the hospital; to recruit and assist in the recruitment of voluntary workers in and for the hospital; to provide a link between Moreton Hospital and the community which it serves; to co-operate with all bodies for the benefit of the hospital and to relieve patients and former patients of Moreton Hospital who are sick, convalescent, disabled, handicapped, infirm or in need of financial assistance and generally to support the charitable work of Moreton Hospital.

The Trustees who act for the charity are appointed at the AGM. Three Trustees retire by rotation each year. New trustees are usually recruited from amongst the local community and selection is based on the recommendations of existing trustees. There are no restrictions on the minimum or maximum number of trustees in office at any one time.

Trustees look at ways to expend the annual income for the benefit of the hospital, its patients and it's staff with the absolute minimum of administrative costs. The trustees also endeavour to hold a minimum of £150,000 as a general reserve against future major or other capital expenditure of the hospital. This has proved to be a successful arrangement in preserving our hospital whilst others unfortunately have tended to suffer.

Chairman's Report

Moreton Hospital, as usual, continues to provide great service. We as the League of Friends have tried to help wherever possible. We have provided new equipment, a pachmate and corner steps, the first for the ophthalmic clinic and the latter to help stroke patients to manage stairs again. We have helped with the upkeep of the Gardens by funding regular mowing and hedge cutting and we have paid for some tree maintenance. There are a group of gardeners who come on Wednesdays and we have paid for additional work on the NFU Garden. We have also paid for a huge delivery of aged tree chippings to go on the flowers beds to keep in the moisture and help keep the weeds at bay. We continue to provide newspapers, coffee and tea for the staff and flowers for patients and staff who are ill or suffering in some additional way. We ordered five Christmas Trees for the Hospital, 3 large outside ones, and one in reception and one upstairs on the wards. We also gave a further £250 for the upstairs staff and £250 for MIU and downstairs. We paid for a visit, by live penguins which apparently caused great amusement and their visit was much appreciated by the Patients... This year we are reverting to the more usual Christmas Party and will sponsor the evening at the Cotswolds Hotel & Spa at Chipping Norton. The Hospital is now almost back to normal following Covid and I understand more than 80 thousand covid vaccinations were given at the Hospital. Bed occupancy has maintained its 98 % average and there were over 10,000 cases seen at the MIU The X ray dept has new equipment and has been busy and there were over 8000 patients seen at the various clinics including Dermatology Heart, Hearing etc There is now also a counselling group attached to the Hospital and the Community Nurses work from one of our dedicated rooms. Funds continue to come in. There and the usual lots of smaller amounts following funerals but there have been several large bequests including one of over £70 thousand from a Mr Thompson from Blockley. Allen and Son, the undertakers, held a Mince Pies and Memory evening and gave us the funds they raised. So, all in all we are very lucky to be able to have such an excellent facility to provide such a valuable service for our community. You may know the Bourton- on- the Water League of Friends will now finally close next year so we can count ourselves fortunate to be able to go from strength to strength, and this in no small measure to people like your good selves who so kindly continue to support the league of Friends.

I will now ask the treasurer to give his report and go into more detail of our income and expenditure.


