Financial Review

Donations have been received from some of our patients and their relatives. Expenditure is down on previous years as salaries are no longer funded from this charity, however cost of living has increased costs incurred.
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	Our financial policy has been to keep the bulk of the income on monthly Treasury Deposit with the rest in current and instant accounts to meet our expenditure. We have a Business Premium account that automatically transfers money from our current a/c to an interest bearing a/c. Our costs fluctuate as the costs of reagents and service contracts vary therefore the trustees policy is to hold reserves of around 12 months of forecast expenditure. 12 months period gives the BLF time to scale back or plan new fund-raising schemes.
