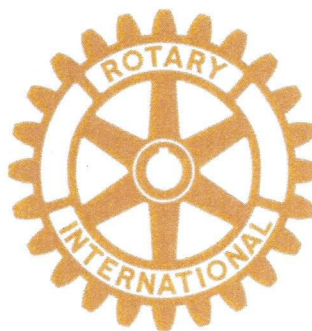

TRUSTEES' REPORT FOR THE YEAR ENDED 30 JUNE 2023

The Trustees present their annual report and the financial statements for the year to 30 June 2023.

Charitable Objects and Public Benefit

The Trust administers the funds held for charitable purposes by Rotary International District 1080. The Trust Deed empowers the Trustees to hold monies received upon trust to apply both capital and income for such charities or for such charitable objects as the Trustees may in their absolute discretion decide having regard to:

- Any wishes expressed by a Rotary Club in District 1080 when donating funds; or
- Any direction given by the District Council of R.I. District 1080; or
- Any direction given by the District Executive Committee of R.I. District 1080.
- The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities and setting the grant making policy for the year.

Achievements and performance

During the year the Trust pursued its charitable objects with the following projects:

Help for Ukraine Fund: This is a restricted fund and raises money to donate to Rotary Clubs to fund humanitarian help to the people of Ukraine in response to the Russian invasion of their country. During the year, £10,018 was donated by Rotary Clubs and individuals in the District in addition to £10,729 brought forward from the previous year. Grants totalling £20,747 were paid to the Rotary Club of Kyiv International in Ukraine.

Pakistan Flood Appeal and Turkey/Syria Earthquake Appeal: these are restricted funds and raised money to donate to the Rotary in Great Britain and Ireland appeals. The totals raised and paid over to RGBI were £4,990 and £2,550 respectively.

Turkey Container Village: This is a restricted fund and raises money to fund the purchase of shipping containers converted into living accommodation for people made homeless by the earthquake in Turkey in February. As at 30 June 2023, £8,665 has been donated by Rotary Clubs in the District.

Structure, Governance and Management


The trust is governed by a Deed dated 26 July 1984 as amended on 13 February 2013 and registered as a charity on 26 November 1984. Trustees are appointed by the District Council of the Rotary District 1080. The maximum number of trustees is 5 and minimum 3. Trustees hold office for a term of 5 years and may be re-appointed.

The Charity is run by its Trustees and supported by the Clerk and Rotarians in District 1080.

Financial Review

The General Fund can be used for any purpose that meets the objects of the charity. At the year end the balance held was £27. The Trust has no operational costs as these are borne by the District 1080 General Fund. There is no policy to maintain a particular level of reserves. Most of the funds held are restricted or designated for staging specific events.

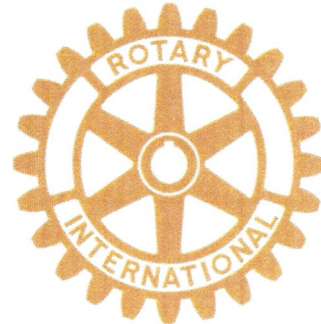

Governing Document

The trust is governed by a Deed dated 26 July 1984. The Deed was amended on 13 February 2013 to incorporate current best practice for the operation of the trust.

Charitable Objects

The Trust administers the funds held for charitable purposes by Rotary International District 1080.

The Trust Deed empowers the Trustees to hold monies received upon trust to apply both capital and income for such charities or for such charitable objects as the Trustees may in their absolute discretion decide having regard to:

- Any wishes expressed by a Rotary Club in District 1080 when donating funds; or
- Any direction given by the District Council of R.I. District 1080; or
- Any direction given by the District Executive Committee of R.I. District 1080.

Charitable activities for the year ended 30 June 2022

General Fund: This fund can be used for any purpose that meets the objects of the charity. £8 was held at the year end.

Help for Ukraine Fund: This is a restricted fund and raises money to donate to Rotary Clubs to fund humanitarian help to the people of Ukraine in response to the Russian invasion of their country. During the year, £45,729 was donated by Rotary Clubs and individuals in the District. Grants totalling £35,000 were paid to Rotary Clubs in Poland, Moldova and Ukraine.


Voluntary Support

The Charity relies on the voluntary services of its Trustees and Clerk and of the Rotarians in District 1080.

Reserves and reserves policy

There is no policy to maintain a particular level of reserves. Most of the funds held are restricted or designated for staging specific events. The General Fund may be used for any purpose that meets the objects of the charity.
