Objects: I) TO ADVANCE EDUCATION AND IN PARTICULAR THE EDUCATION OF CHILDREN IN ASIAN LANGUAGES AND CULTURE INCLUDING THE ARTS OF MUSIC, DANCE, DRAMA AND TO ADVANCE EDUCATION IN ACCORDANCE WITH THE TENETS AND TEACHINGS OF HINDUISM.
