TO ASSIST THE RESTORATION AND PRESERVATION OF BUILDINGS AND ARTEFACTS IN FROME AND THE SURROUNDING AREA AND TO COMMISSION COMMEMORATIVE PLAQUES BY THE PROVISION OF GRANTS.
