**Objects:** PROPERTY TO BE HELD IN TRUST FOR THE PURPOSES OF PHYSICAL AND MENTAL TRAINING, RECREATION AND SOCIAL, MORAL AND INTELLECTUAL DEVELOPMENT THROUGH MEDIUM OF READING AND RECREATION ROOMS, LIBRARY, LECTURES, CLASSES, RECREATIONS AND ENTERTAINMENTS OR OTHERWISE FOR BENEFIT OF INHABITANTS LIVING WITHIN HALF A MILE RADIUS OF BURNHAM GREEN CROSS ROADS.

**Activities:** To hold the Village Hall upon trust for the people of Burnham Green for the purposes of recreation, social, moral and intellectual development, entertainment, or other activities decided upon by the committee, for the benefit of the inhabitants of Burnham Green. Burnham Green is defined as being within half a mile of the crossroads at Burnham Green, Hertfordshire.
