Activities: The trust holds and administers a trust fund for the promotion of religious work carried out by the company of Christians presently meeting in the Meeting Room, Palace Gardens, Buckhurst Hill, Essex, and by other gatherings of Christians in common with the said company of Christians either in the British Isles or Overseas, and for such other charitable purposes as the Trustees shall think fit.
