(B) THE PRESERVATION FOR THE BENEFIT OF THE NATION AND AS AN ADJUNCT TO ANY SUCH BUILDINGS OR GARDENS AS AFORE-SAID OF FURNITURE PICTURES AND OTHER CHATTLES OF NATIONAL HISTORIC OR ARTISTIC INTEREST (C) THE ADVANCEMENT OF THE HISTORICAL ARCHITECTURAL AESTHETIC AND HORTICULTURAL EDUCATION OF THE PUBLIC (D) THE GENERAL PURPOSES OF SUCH CHARITABLE BODIES AND IN PARTICULAR (BUT WITHOUT PREJUDICE TO THE GENERALITY OF THE FOREGOING) FOR THE GENERAL PURPOSES OF ANY EXCLUSIVELY CHARITABLE BODY REGISTERED UNDER SECTION 4 OF THE CHARITIES ACT 1960 WHICH COMPRISES ARLEY HALL THE GROUNDS OF ARLEY HALL OR ITS SURROUNDING BUILDINGS AMONGST ITS ASSETS OR FOR SUCH OTHER PURPOSES AS SHALL BE EXCLUSIVELY CHARITABLE AS THE TRUSTEES MAY FROM TIME TO TIME DECIDE.
