CHAIR'S STATEMENT FOR THE YEAR ENDED 31 MARCH 2025

The Chair presents his statement for the year.

St George's is a vital, thriving hub for music in Bristol. Some of its diverse and varied programme of events we programme ourselves, as part of our remit to engage local citizens with music; some are performances on which we work in partnership with promoters and artists; and it is also pleasing to welcome a growing range of organisations who host their own events, meetings, conferences, lectures and workshops. Consequently, St George's is increasingly busy throughout the day, fully justifying our long term ambition to be open all hours for people and music.

The year was significantly impacted by the programme of works carried out to the roof of the new extension, which necessitated a longer period of closure over the summer than is usual. I am delighted to be able to say that the works were completed on schedule despite some increases in scope and came in slightly below the budgeted cost. This was due to the excellent collaboration between the St George's team and the contractors, and the Trustees would like to take this opportunity of recording their sincere thanks to both teams for resolving this long-running issue. The trustees would also like to thank the very loyal group of supporters who contributed to the "Roof Stars" campaign to fund the works, led by our former Chair, Ben Heald, who also kindly stayed on the steering group to see the project through to completion.

From a financial perspective, there was an operational loss of £20k for the year (2024: loss of £3k), and an increase in funds of £127k. The Board believes that this was a creditable performance on the part of the management team given the impact of the roof repairs noted above.

Lastly the trustees would like to record their thanks to Sue Rigby for her brief tenure as Chair. Subsequent to joining St George's, Sue was offered the role of Vice-Chancellor at Edinburgh Napier University and, given that her long-held ambition was to retire to that city, understandably decided to accept it and due to the need to focus on her new role regretfully tendered her resignation in February of this year. A recruitment process for the position of Chair has been launched with the expectation of having the new incumbent in place for September.

**TRUSTEES' REPORT
FOR THE YEAR ENDED 31 MARCH 2025**

The Trustees are pleased to present their annual report together with the financial statements of the charitable company ('the Charity', 'the Company' or 'St George's') for the year ended 31 March 2025. Reference and administrative details are set out on page 1 and form part of this report.

The Annual Report serves the purposes of both a Trustees' report and a Directors' report under company law. The Trustees confirm that the Annual Report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Objectives and Activities

The objectives of the Charity are to:

- Promote an appreciation and understanding of music through its performance and study, and
- Preserve for the benefit of the general public the historic and architectural heritage of the building and surrounding grounds.

The Charity's vision is to create unforgettable experiences by bringing together exceptional artists with local audiences and communities, realised through its mission of connecting people through remarkable music and cultural experiences at our iconic Bristol venue by supporting outstanding artists, inspiring audiences and engaging with communities in Bristol and beyond.

Public benefit

The Trustees have complied with the Charities Act 2011 and their duty to have due regard to the Charity Commission's public benefit guidance when exercising powers and duties to which the guidance is relevant.

Achievements and Performance

We have had the usual busy year of live music and spoken word events, alongside our thriving creative learning and community engagement programme. In total, some 300 events, including our cultural programme and private hires, welcoming over 120,000 people through our doors.

Our classical programme was as vibrant as ever. Our piano concerts are always popular - we welcomed the 2024 Leeds International Piano Competition winner, Jaeden Izik-Dzurko, alongside international stars Pavel Kolesnikov and Anna Tsybuleva. Our new "Classical Up Close" series worked well, with audiences sat in the round close to the artists in our intimate space.

We had a particular focus on baroque music, which included Academy of Ancient Music with countertenor Reginald Mobley, and the return of Rachel Podger with Brecon Baroque. We also celebrated the anniversaries of Holst, with a performance of his ever-popular The Planets with Hans Zimmer's Interstellar performed by Bristol Ensemble, and then Palestrina and Arvo Part, in a sold-out concert by the Tallis Scholars which was crowned by a 5-star review in the Guardian.

In our broader music offer, including folk, jazz and roots, a highlight was Courtney Pine's 60th birthday party, with a packed standing gig. We also welcomed a variety of artists to St George's for the first time, including sitarist Jasdeep Singh Degun, various artists as part of our 'Rising Folk' strand, and also Lighttime Music, a new series of daytime concerts in partnership with Mothers in Music.

Our Thursday lunchtime classical recital series is flourishing with the very best talent on display with everything from solo percussion to baroque ensemble. Alongside, we are also building audiences for our new Friday jazz strand, again promoting emerging talent. In January we collaborated with researchers from the southwest-based MyWorld project to present two lunchtime recitals, one classical, one jazz. A team of scientists investigated how live music affects both audiences and performers, and what sets this experience apart from listening to a recording or watching a video.

We held our third Festival of Voice in June. A key initiative was our new Sing for Happiness project bringing together hundreds of singers together with specialist researchers from the University of the West of England to look into the impact of singing on our well-being and mental health. We have been pleased with the results so far, with a third of the participants saying they have not sung since they were children, if at all. The summer project was so successful we repeated it at Christmas.

Our creative learning programme and community work continues to expand. Cosmos is flourishing, this is our weekly children's community singing project, based out of two schools in the Knowle West area of Bristol. We were pleased to arrange performance opportunities for them, including at Tyntesfield. Our Community Ticket Club has grown to include more partners.

Fundraising, commercial venue hire, and hospitality income continue to be an important part of our financial success as the income generated from ticket sales only accounts for around 40% of our operating income. We relaunched our Membership programme, with revised levels and a refreshed range of benefits. We are grateful to our family of philanthropic supporters, members, commercial clients and partners for our continued success and growth.

The Trustees would also like to thank the staff at St George's and the many volunteers who enable the organisation to thrive.

Investment Policy and Performance

Under the terms of the governing document the Charity has the power to make any investment that the Trustees see fit. The Board, having regard to the liquidity requirements of operating St George's, has a policy of holding any surplus funds as cash investments and seeks to maximise returns on such deposits whilst minimising any credit risk.

Creditor Payment Policy

It is St George's policy to pay creditors in accordance with terms of payment agreed at the start of business with each supplier.

STRATEGIC REPORT

FINANCIAL REVIEW

The improvement in operational performance of the Charity seen last year was maintained. However, income from trading activities in the current financial year was down on the previous year as a result of the longer summer shutdown period to enable the roof works on the new extension to be carried out. The project was delivered on time and, despite a small increase in scope, came in slightly below budgeted costs.

Review of the Year

St George's result for the year was an operational loss of £20k (2024: £3k loss) and an overall increase in funds of £127k.

The full financial statements are set out on pages 12 to 30.

Risk Management and Reserves Policy

St George's programmes concerts and other events which necessarily have to be planned in advance, some up to 3 years ahead. Staff are employed through contracts of employment. Income and expenditure are seasonal we promote concert seasons and many buy tickets in advance. We also have to consider risks to the Charity.

The Trustees regularly review and update the key risks to the Charity which include:

- those which affect the number of tickets bought for events, including competition;

- those which affect performances;
- other trading risks; and
- estates and compliance risks, including health and safety risks.

All of these risks are managed continuously, and mitigations are put in place as required. These include:

- marketing and advertising;
- repairs and maintenance; and
- discussion and resolving issues with performers, funders and regulators.

Many of the associated costs are already borne by the Charity in budgets, eg salaries and regular maintenance, but where additional cost is incurred, it is charged against income in the year in question. The Trustees have concluded that the Charity needs to hold some reserves to deal with unanticipated changes in the level of income, in particular ticket sales.

The Trustees maintain insurance against business interruption.

Risk of unplanned closure

The Charity Commission requires us to consider whether reserves are required to cover the possibility of unplanned closure. The Trustees plan for the long term on the basis that St George's will grow and develop, enhancing its services while managing the risks it faces. At the present time, the Trustees do not foresee any significant risk of unplanned closure but see the need to retain reserves to cover the risk of fluctuations in ticket sales.

Reserves held by the charity

The Trustees conclude that the Charity needs to hold reserves to cover the contractual commitment it makes to performers and staff in the medium term in the event that there is an unanticipated downturn in the sale of tickets for performances at St George's.

The Trustees estimate that an equivalent of three months of artists' fees and staff salaries is the minimum required to cover this risk and have set a minimum level of free reserves of £300k.

At 31 March 2025, the level of free reserves was £239k.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

St George's Bristol is a company limited by guarantee and registered as a Charity with the Charity Commission. It is governed by its Articles of Association.

Organisational Structure and Decision Making

The governing body of the charitable company is the Board. The Directors are also the Charity's Trustees for the purposes of Charity law and are generally referred to as the Trustees. The Board meets 6 times a year with the Chief Executive and senior staff in attendance. It is involved in major strategic decisions and has ultimate responsibility for the conduct and financial stability of St George's. Committees and working parties are established for relevant purposes. At present there is a committee in place for Finance and Operations, a Working Party to manage the recruitment of a new chair and a separate Working Party for the new membership scheme. All meet regularly and are accountable to the Board.

The Chief Executive manages the day-to-day operations of the Charity. The Board appoints the Chief Executive and is also involved in the recruitment of other members of the senior management team, determines their contracts of employment and reviews pay and performance.

Trustees are recruited for an initial term of 3 years through a process of advertisement and interview. Appointments may be extended where appropriate to the needs of the organisation. There is an induction process for new Trustees.

The Charity's wholly owned subsidiary, SGB Enterprises Limited, manages commercial activities. It donates its taxable profits to the Charity by way of Gift Aid.

FUTURE PERIODS

We look forward to our ever-varied programme, bringing back St George's favourites and welcoming new artists to help keep our programme fresh and relevant, and attract new and more diverse audiences. We will be working even closer with our partners at BBC Radio 3, including a Prom and further engagement with the New Generation Artists. A particular highlight will be international Make Music Day, when we will take the lead in filling Bristol with music from a wide range of groups.

INFORMATION ON FUNDRAISING PRACTICES

The majority of St George's income is from tickets, trading and grants. We also offer individuals a range of ways of contributing to our work through season tickets and membership schemes, which we promote through brochures, programmes, and our digital communications. We fully comply with the GDPR regulations and have had no complaints about any aspect of our fundraising.

Financial risk management

The Trustees have assessed the major risks to which the Group and the Charity are exposed. In particular those related to the operations and finances of the Group and the Charity, and are satisfied that systems and procedures are in place to mitigate exposure to the major risks.

Auditors

In so far as the Trustees are aware:

- there is no relevant audit information of which the charitable Group's auditors are unaware; and
- the Trustees have taken all steps that they ought to have taken to make themselves aware of any relevant audit information and to establish that the auditors are aware of that information.

The auditors, Bishop Fleming LLP, are willing to continue in office and a resolution to appoint them will be proposed at the annual general meeting.

**STATEMENT OF TRUSTEES' RESPONSIBILITIES
FOR THE YEAR ENDED 31 MARCH 2025**

The Trustees (who are also the directors of the Charity for the purposes of company law) are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the Trustees to prepare financial statements for each financial year. Under company law, the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the Group and the Charity and of their incoming resources and application of resources, including their income and expenditure, for that period. In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles of the Charities SORP (FRS 102);
- make judgements and accounting estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards (FRS 102) have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Group will continue in business.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the Group and the Charity's transactions and disclose with reasonable accuracy at any time the financial position of the Group and the Charity and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Group and the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF ST GEORGE'S BRISTOL

OPINION

We have audited the financial statements of St George's Bristol (the 'parent charitable company') and its subsidiaries (the 'group') for the year ended 31 March 2025 which comprise the Consolidated Statement of Financial Activities, the Consolidated Balance Sheet, the Charity Balance Sheet, the Consolidated Statement of Cash Flows and the related notes, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice).

In our opinion the financial statements:

- give a true and fair view of the state of the Group's and of the parent charitable company's affairs as at 31 March 2025 and of the Group's incoming resources and application of resources, including its income and expenditure for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

BASIS FOR OPINION

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the Auditors' responsibilities for the audit of the financial statements section of our report. We are independent of the Group in accordance with the ethical requirements that are relevant to our audit of the financial statements in the United Kingdom, including the Financial Reporting Council's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

CONCLUSIONS RELATING TO GOING CONCERN

In auditing the financial statements, we have concluded that the Trustees' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the Group's or the parent charitable company's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

Our responsibilities and the responsibilities of the Trustees with respect to going concern are described in the relevant sections of this report.

OTHER INFORMATION

The other information comprises the information included in the Annual Report other than the financial statements and our Auditors' Report thereon. The Trustees are responsible for the other information contained within the Annual Report. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon. Our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the course of the audit, or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether this gives rise to a material misstatement in the financial statements themselves. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

OPINION ON OTHER MATTERS PRESCRIBED BY THE COMPANIES ACT 2006

In our opinion, based on the work undertaken in the course of the audit:

- the information given in the Trustees' Report for the financial year for which the financial statements are prepared is consistent with the financial statements.
- the Trustees' Report has been prepared in accordance with applicable legal requirements.

MATTERS ON WHICH WE ARE REQUIRED TO REPORT BY EXCEPTION

In the light of our knowledge and understanding of the charitable company and its environment obtained in the course of the audit, we have not identified material misstatements in the Trustees' Report.

We have nothing to report in respect of the following matters in relation to which Companies Act 2006 requires us to report to you if, in our opinion:

- the parent charitable company has not kept adequate and sufficient accounting records, or returns adequate for our audit have not been received from branches not visited by us; or
- the parent charitable company financial statements are not in agreement with the accounting records and returns; or
- certain disclosures of Trustees' remuneration specified by law are not made; or
- we have not received all the information and explanations we require for our audit.

RESPONSIBILITIES OF TRUSTEES

As explained more fully in the Trustees' Responsibilities Statement, the Trustees (who are also the directors of the charitable company for the purposes of company law) are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the Trustees determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Trustees are responsible for assessing the Group's and the parent charitable company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Trustees either intend to liquidate the Group or the parent charitable company or to cease operations, or have no realistic alternative but to do so.

AUDITORS' RESPONSIBILITIES FOR THE AUDIT OF THE FINANCIAL STATEMENTS

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an Auditors' Report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

- We have considered the nature of the sector, control environment and financial performance;
- We have considered the results of enquiries with management and Trustees in relation to their own identification and assessment of the risk of irregularities within the entity;
- We have reviewed the documentation of key processes and controls and performed walkthroughs of transactions to confirm that the systems are operating in line with documentation; and
- We have considered the matters discussed among the audit engagement team regarding how and where fraud might occur in the financial statements and potential indicators of fraud.

As a result of these procedures, we have considered the opportunities and incentives that may exist within the organisation for fraud and identified the highest area of risk to be in relation to revenue recognition, with a particular risk in relation to year-end cut off. In common with all audits under ISAs (UK) we are also required to perform specific procedures to respond to the risk of management override.

We have also obtained understanding of the legal and regulatory frameworks that the Charity operates in, focusing on provisions of those laws and regulations that had a direct effect on the determination of material amounts and disclosures in the financial statements. The key laws and regulations we considered in this context included the Charities Act 2011, Charity SORP 2019, FRS 102 and the terms and conditions attaching to material grants received by the Charity.

In addition, we considered the provisions of other laws and regulations that do not have a direct effect on the financial statements but compliance with which may be fundamental to the Charity's ability to operate or avoid a material penalty. These included data protection regulations, health and safety regulations and employment legislation.

Our procedures to respond to the risks identified included the following:

- Reviewing the financial statement disclosures and testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described as having a direct effect on the financial statements;
- Performing analytical procedures to identify unusual or unexpected relationships that may indicate risks of material misstatement due to fraud;
- Review of board minutes;
- Enquiring of management in relation to actual and potential claims and litigations;
- Performing detailed transactional testing in relation to the recognition of revenue, specifically grants, with a particular focus around year-end cut off;
- In addressing the risk of fraud through management override of controls, testing the appropriateness of journal entries and other adjustments.

We also communicated identified laws and regulations and potential fraud risks to all engagement team members and remained alert to any indications of fraud or non-compliance with laws and regulations throughout the audit.

As a result of the inherent limitations of an audit, there is a risk that not all irregularities, including a material misstatement in the financial statements or non-compliance with laws and regulations, will not be detected by us.

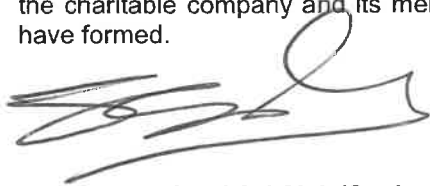

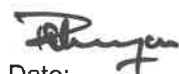

**NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 MARCH 2025**

1. GENERAL INFORMATION

St George's Bristol is a company limited by guarantee and a charity registered at the Charity Commission in England and Wales. The principal address is Great George Street, Bristol, BS1 5RR.

2. ACCOUNTING POLICIES

2.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

St George's Bristol meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

The Consolidated Statement of Financial Activities (SOFA) and Consolidated Balance Sheet consolidate the financial statements of the Group and its subsidiary undertaking. The results of the subsidiary are consolidated on a line by line basis.

The Group has taken advantage of the exemption allowed under section 408 of the Companies Act 2006 and has not presented its own Statement of Financial Activities in these financial statements.

2.2 COMPANY STATUS

The Charity is a company limited by guarantee. The members of the Charity are the Trustees named on page 1. In the event of the Charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the Charity.

2.3 GOING CONCERN

The Trustees consider that there are no material uncertainties about St George's Bristol's ability to continue as a going concern and as a consequence have prepared the accounts on the going concern basis.

2.4 FUND ACCOUNTING

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Group and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the Group for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

2. ACCOUNTING POLICIES (continued)

2.5 INCOME

All income is recognised once the Charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

The recognition of income from legacies is dependent on establishing entitlement, the probability of receipt and the ability to estimate with sufficient accuracy the amount receivable. Evidence of entitlement to a legacy exists when the Charity has sufficient evidence that a gift has been left to them (through knowledge of the existence of a valid will and the death of the benefactor) and the executor is satisfied that the property in question will not be required to satisfy claims in the estate. Receipt of a legacy must be recognised when it is probable that it will be received and the fair value of the amount receivable, which will generally be the expected cash amount to be distributed to the Charity, can be reliably measured.

Other income is recognised in the period in which it is receivable and to the extent the goods have been provided or on completion of the service.

2.6 EXPENDITURE

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities. Support costs are those costs incurred directly in support of expenditure on the objects of the Charity.

Costs of generating funds are costs incurred in attracting voluntary income, and those incurred in trading activities that raise funds.

Charitable activities are costs incurred on the Charity's educational operations, including support costs and costs relating to the governance of the Charity.

All expenditure is inclusive of irrecoverable VAT.

2.7 BASIS OF CONSOLIDATION

The financial statements consolidate the accounts of St George's Bristol and all of its subsidiary undertakings ('subsidiaries').

The Charity has taken advantage of the exemption contained within section 408 of the Companies Act 2006 not to present its own income and expenditure account.

The surplus for the year dealt with in the accounts of the Charity was £127k (2024: £94k deficit)

2.8 TANGIBLE FIXED ASSETS AND DEPRECIATION

Tangible fixed assets are carried at cost, net of depreciation and any provision for impairment. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

2.8 TANGIBLE FIXED ASSETS AND DEPRECIATION (CONTINUED)

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives.

Depreciation is provided on the following bases:

Pianos	- straight line over 25 years
Equipment and fittings	- straight line over 2-15 years

No depreciation is charged on leasehold property as in the opinion of the trustees the property has a high residual value in the event of a sale in the foreseeable future and any charge would not be material.

2.9 INTEREST RECEIVABLE

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the Charity; this is normally upon notification of the interest paid or payable by the bank.

2.10 STOCKS

Stocks are valued at the lower of cost and net realisable value after making due allowance for obsolete and slow-moving stocks.

2.11 DEBTORS

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

2.12 CASH AT BANK AND IN HAND

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of six months or less from the date of acquisition or opening of the deposit or similar account.

2.13 LIABILITIES AND PROVISIONS

Liabilities are recognised when there is an obligation at the Balance Sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

Liabilities are recognised at the amount that the Charity anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised in the Consolidated Statement of Financial Activities as a finance cost.

2.14 FINANCIAL INSTRUMENTS

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

RESTRICTED FUNDS

The Artistic and Learning & Participation Projects Fund comprises funds received from Trusts and Sponsors, as well as Arts Council England towards Bristol Music Consortium activities and other Learning & Participation projects.

The Fixed Assets Fund comprises the fund originally set up for the work needed to develop the facility at St George's Bristol and other donations received for fixed asset purposes, together with donations received from Trusts and individuals towards the construction of the new extension. The fund balance represents the net book value of expenditure that has been capitalised, together with donated assets, mainly as leasehold property (note 11). The fund balance is being reduced each year by the depreciation charged on the assets, where applicable.

The Remedial Capital Works Fund comprises funds received for the programme of remedial capital works planned for, and completed in the summer of 2024. On completion, these were subsequently capitalised and are shown within the fixed asset fund.

The Bursary Fund represents funds received for the purpose of supporting the development of talented young musicians.

The Other Restricted Fund relates to donations received for the upgrading and refurbishing of external areas of St Georges Bristol

UNRESTRICTED DESIGNATED FUNDS

The Remedial Capital Works Fund comprises funds ring-fenced for the programme of remedial capital works planned for, and completed in the summer of 2024. On completion, these were subsequently capitalised and are shown within the fixed asset fund.

The Agency Fund represents income received and held on behalf of third parties.

The Fixed Assets Fund comprises those capital projects and purchases carried out to develop the facility at St George's Bristol, and purchased through unrestricted funds.

UNRESTRICTED GENERAL FUNDS

Charity funds represent the income that is received through donations, grants, fundraising and other forms of income, to assist with the overall running of St George's Bristol.

22. RELATED PARTY TRANSACTIONS

In addition to their time, Trustees gave donations totalling £54k (2024: £9k) to St George's Bristol.

During the year, purchases totalling £584,018 (2024: £Nil) were made from Clever Space Construction Limited, a Company owned by one of the Trustees.

In order to manage this conflict of interest, the Board put in place a number of measures:

1. The conflicted trustee recused themselves from all Board discussions regarding the tendering process and any associated financial and contractual discussions in connection with the roof works.
2. A competitive tender process was run, overseen by a suitably qualified trustee supported by external consultants where relevant, and the tender award was ratified by the full Board, less the conflicted trustee.
3. An appropriately qualified steering group was established to oversee the project comprising appropriately experienced trustees, management and Clever Space representatives.

As noted in the Chair Statement earlier in the Annual Report, the project was completed to time despite some expansion of scope and came in slightly below the budgeted cost.
