TO SUPPORT THE CHARITABLE WORK OF THE NATIONAL SOUND ARCHIVE OR OTHER CHARITABLE ORGANISATION IN SO FAR AS THEY RELATE TO WILDLIFE SOUND AND COMMUNICATION.
