Additional information

The Charity is not a grant making charity or involved in social investment. The Charity is run by a Community Hall Committee (CHC) which is made up of volunteers and the Harting Parish Council acting as the Sole Managing Trustee is also made up of volunteers. The Charity has one employee who is the Hall's caretaker.

Achievements and Performance

The last year has been another year of progress for the Hall with usage levels holding up, further refurbishment projects, continued development of our 'Harting Film Night' activities and progress on our solar project with the valuable assistance of Harting CAN. Despite increases in many of our overheads and other costs, we have not increased our charges, and a small profit was made for the year.

The most visible signs of the refurbishment are the enhancements of the bar and further upgrading of the audio systems, the latter thanks to the further generous support of the Harting Society. Also further upgrading of the old upstairs committee room, now called The Humphrey Sladden Room, to further enhance it as a small flexible and well-equipped room available for hire and the showing of films and running courses, such as a very popular Wine Tasting course. The continued development of the Harting Film Nights with the successful introduction of Glyndebourne Opera evenings where everyone brings a picnic and more recently an Indie Film Night in the Humphrey Sladden Room. These are as well as the regular monthly Film Nights, the afternoon showings of Art films in the Humphrey Sladden Room and the very popular National Theatre Live showings. This has led to a welcomed increase in the Hall's income and is very instrumental in the Hall making a small profit.

Although this is a positive picture, the future holds many challenges with continued inflationary pressures and retaining our regular users and attracting new users and activities, as well as maintaining and refurbishing a building that is beginning to show its age and in places wear out. It is against this background that the Solar Project which we have developed with Harting CAN is so important. The project is to substantially increase our solar power capacity and so generate a significant and stable income for the Hall which will then allow us to remove our dependence on oil. We have made significant progress in gaining planning permission, obtaining quotes and securing substantial financial backing from the Harting Parish Council, although this will still mean that we must raise further funds over the next year, but we hope to tie up the last loose ends shortly and be able to proceed. This should be a game changer for the Hall's longer term financial security.

Reserves Policy

The Charity's current policy is to hold all its funds in cash at the NatWest Bank.

At the year end the Charity had £8,938 in a separate NatWest deposit account from its day-to-day banking account. This reserve is held primarily to ensure continuity in the event of an unexpected significant adverse variation of income or to cover emergency expenditures. In the normal course of events the Reserve would be expected to be in the range of £5,000 to £10,000 and would be funded from any monies in the NatWest current account considered to be surplus to those required to meet budgeted expenditure or from any donations. However, monies may be added to the reserve if it is decided to build up a specific pot to pay future planned expenditure. The Reserve account is monitored at each meeting of the CHC and this policy annually or as required.

Structure, Governance and Management

The Charity is governed by a Lease and Trust Deed dated 10th November 1986 as amended on 9th December 2022.

The Charity has a Sole Managing Trustee (SMT) which is undertaken by The Harting Parish Council (HPC). The membership, therefore, of the SMT is that of the HPC. The SMT appoints a Community Hall Committee to provide the day to day management of the Charity and the hall.


The lease which the Charity has on the Community Hall building is held on the Charity's behalf by the Official Custodian for Charities. The freehold of the building is owned by The Harting Parish Council.

The Charity has one employee who is the Hall's caretaker.

Achievements and Performance

The last year has been a challenging year for the Hall, but also a very positive one. The main challenges have been the substantial increase in the Hall's energy costs and other inflationary pressures, as well as the need to undertake necessary and overdue maintenance and refurbishments. The positive aspects have been the Harting Parish Council becoming the Sole Trustee, the supportive attitude of our regular users to the necessary increased hire charges, increased usage of the Hall and the introduction of new activities.

The most visible signs of the refurbishment are the enhancement of the entrance hall and the main hall, a new sign and notice board outside the hall and further upgrading of the audio systems, the latter thanks to the generous support of the Harting Society. But probably the most significant change is the upgrading of the old upstairs committee room, now called The Humphrey Sladden Room, to become a small flexible and well-equipped room available for hire. More refurbishment in other parts of the Hall is planned in the future.

The greater usage of the hall reflects the return of ad hoc hirings for birthday parties and similar events post Covid, as well as the continued development of the Harting Film Nights to now include regular afternoon showings of Art films and, more significantly, the introduction of National Theatre Live showings. This has led to a welcomed increase in the Hall's income and should allow the Hall to improve profitability in the next year.

Although this is a positive picture, the future holds many challenges in both retaining our regular users, particularly the Pre-School, and attracting new users and activities, as well as maintaining and refurbishing a building that is beginning to show its age and in places wear out. To substantially lower our carbon footprint, as well as improving our income, we are investigating with Harting CAN's support a plan to substantially increase our solar power capacity and remove our dependence on oil.

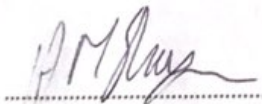
