The reason for closure was that in the view of the trustees operations were no longer sustainable due to falling demand, rising costs, and the difficulty in attracting volunteers.

The trustees do not consider that any additional permissions to close are required.

Following the sale of the charity's property and the settlement of expenses, the charity was left with funds of £183,036. These were distributed by way of donation to the following local charities:

At the date of closure no restricted or endowment funds were held, and all conditions relating to grant income previously received had been fulfilled.
