Objects: (A) THE ADVANCEMENT OF EDUCATION BY THE FURTHERANCE OF RESEARCH INTO PERSONAL FREEDOM UNDER THE LAW OF ANY NATION IN THE WORLD AND THE DISSEMINATION OF THE USEFUL RESULTS OF SUCH RESEARCH. (B) TO PROVIDE FINANCIAL AND OTHER CHARITABLE RELIEF FOR ANY PERSON IN NEED WHO IS OR HAS BECOME A REFUGEE THROUGH A WELLFOUNDED FEAR OF BEING PERSECUTED FOR REASONS FOR RACE RELIGION NATIONALLY MEMBERSHIP OF A PARTICULAR SOCIAL GROUP OR POLITICAL OPINION AND FOR HIS OR HER DEPENDANTS. (C) FOR SUCH OTHER CHARITABLE PURPOSES AS THE TRUSTEES MAY IN THEIR ABSOLUTE DISCRETION DECIDE.
