for the Year Ended 31 December 2024

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 December 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

The financial statements have been prepared in accordance with the accounting policies set out in notes to the accounts and comply with the charity's governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities, preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland, (effective 1st January 2019)

OBJECTIVES AND ACTIVITIES

The original charter states that the company's aim is to provide leisure facilities for local people and holiday visitors at an affordable price. Furthermore, the company has operated a policy which is fair both in principle and practice.

The trustees aim to achieve this by employing the following strategies:

- a) Seeking to promote the availability of the various facilities provided, to members of the public locally and by encouraging membership of the incumbent clubs (tennis club, squash club and bowls club).
- b) Ensuring maintenance, upkeep and where possible upgrading of facilities is made on a regular basis.

The trustees must ensure the company remains profitable for its own survival and price increases reflect this. However, the building of a substantial profit is not an objective.

The company's assets are held to permit it to operate successfully in accordance with its charter. The freehold property and premises, its major asset, is in a unique position where environmental sensitivity calls for very careful management.

In setting their objectives and planning their activities the trustees have given careful consideration to the Charity Commission's general guidance on public benefit.

There have been no material changes in the company's policies in the past year.

ACHIEVEMENT AND PERFORMANCE

During the year the Trustees have achieved the main aims and objectives of the charity, by promoting the facilities and maintaining them to a high standard.

This has led to continued use of the facilities by local people individually and through membership of the clubs and by holiday visitors.

FINANCIAL REVIEW

Financial position

The company's accounts show a net surplus of £42,010, compared to £24,697 in 2023.

Incoming resources show an increase of £48,999 from £119,824 in 2023 to £168,823 in 2024. The company's principal funding source is the provision of facilities. The majority of income received is from the provision of crazy golf and tennis.

Resources expended have increased by £31,686 from £95,127 in 2023 to £126,813 in 2024.

At the year end, the total fund balance including share capital amounted to £341,938 (£299,928 2023). All funds are deemed unrestricted. Reserves are mainly held in the form of fixed assets which are required to meet the company's objectives, and cash and bank balances which are required to fund ongoing maintenance and improvements.

The company currently has sufficient liquid resources to meet its current liabilities as they fall due.

FINANCIAL REVIEW

Reserves policy

The unrestricted reserves of the company are £341,938 at the year end and a substantial part of the reserves is the tangible fixed assets employed by the company for its charitable purpose. The trustees believe that for financial stability the available reserves (the net current assets) should be at least sufficient to cover costs for a period of twelve months. The costs for 2024 amounted to around £126,000.

In addition, the trustees also recognise that reserves have to be set aside for future refurbishment of the facilities it provides. The trustees believe that the reserves need to be built up on a rolling basis to cover £70,000 costs over a ten year period.

The trustees are also aware of one other risk. As the company has failed to obtain flood insurance, the trustees believe that is important to create a flood fund reserve. The level of the reserve is unknown but the trustees believe that is sensible to aim to build a reserve of £100,000+.

Therefore in total the trustees believe the net current assets should be between £126,000 and £296,000. The available reserves at the year end were £164,971 which falls into the lower end of this range.

Going concern

There are no material uncertainties over going concern.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The charity is a private company limited by shares which is registered in England and Wales. Its governing document is its Memorandum and Articles of Association, as amended on 16th May 1987, when charitable status was granted.

Appointment of Trustees

Trustees are appointed by invitation from serving trustees.

Organisation

The board of trustees meet formally every two months. Matters arising between meetings are generally handled by the chairman or the secretary, with due delegated authority, who will report back at the next meeting.

Induction and training of new trustees

Trustees are aware of their legal obligations under charity and company law. New trustees receive a copy of the company's Memorandum and Articles of Association, and are made aware of procedures at trustee meetings, the decision making process, and the recent financial performance of the charity.

In the event of a new appointment, the company secretary and the chairman are jointly charged with briefing a new trustee on their obligations. External training identified by the board, which is considered to be useful for the ongoing stewardship of the charity, is attended by the trustees whenever possible.

Related Parties

There has been no reimbursement of expenses or remuneration to trustees during the period. Transactions between the company and the individual clubs are not considered to be related party transactions.

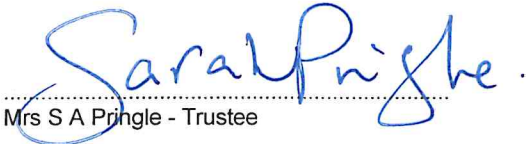

Independent Examiner's Report to the Trustees of
Bude Haven Recreation Ground

I report to the charity trustees on my examination of the accounts of the Company for the year ended 31st December 2024.

Responsibilities and basis of report

As the charity's trustees of the Company (and also its directors for the purposes of company law) you are responsible for the preparation of the accounts in accordance with the requirements of the Companies Act 2006 ('the 2006 Act').

Independent examiner's statement

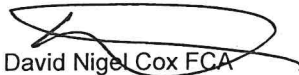

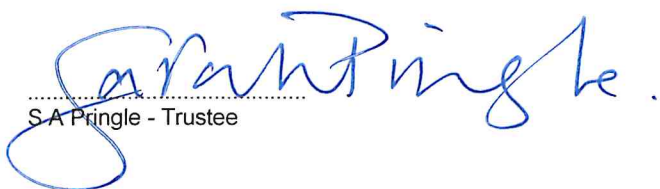

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006, and UK Generally Accepted Accounting Practice.

The financial statements are prepared on a going concern basis as the trustees believe that no material uncertainties exist. The financial statements are presented in sterling which is the functional currency of the charity.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

Financial reporting standard 102 - reduced disclosure exemptions

The charitable company has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland':

- the requirements of Section 7 Statement of Cash Flows;
- the requirement of paragraph 3.17(d).

Income

All incoming resources are included in the Statement of Financial Activities (SoFA) when the charity is legally entitled to the income after any performance conditions have been met, the amount can be measured reliably and it is probable that the income will be received. The policies adopted for the recognition of income are as follows:

Income from charitable activities is derived from the provision of leisure facilities. This is recognised when those facilities have been used. Included in income from charitable activities are annual subscriptions which are recognised over the period to which they relate. For subscription periods which are not co-terminus with the financial statements, the element of the subscription which relates to use in the following financial year is deferred and carried forward in deferred income.

Rentals receivable under operating leases are charged to the SoFA on a straight line basis over the period of the lease.

Expenditure

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Expenditure is recognised where there is a legal or constructive obligation to make payments to third parties, it is probable that the settlement will be required and the amount of the obligation can be measured reliably.

Allocation and apportionment of costs

Support costs are those that assist the work of the charity but do not directly represent charitable activities and include office costs, governance costs, administrative and payroll costs. Governance costs include those involved in the public accountability of the trust and its compliance with regulation and good practice.

The trustees believe that there is only one charitable activity and support costs have been allocated as per the analysis shown in note 6.

Tangible fixed assets

Tangible fixed assets are stated at cost less accumulated depreciation and accumulated impairment losses. Cost includes costs directly attributable to making the asset capable of operating as intended.

Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost, less estimated residual value, of each asset on a systematic basis over its expected useful life as follows:

Land and buildings	- Nil
Other tangible fixed assets	- 5% - 20% per annum on cost

Assets are not generally capitalised below a value of £150.

1. ACCOUNTING POLICIES - continued

Tangible fixed assets

The policy of the directors is to maintain the freehold buildings to a good standard of repair and so in their opinion no depreciation is required as the expected residual value of the buildings at the end of their useful life is above the carrying value in the accounts.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Employee benefits

When employees have rendered service to the charity, short-term employee benefits to which the employees are entitled are recognised at the undiscounted amount expected to be paid in exchange for that service.

The charity operates a defined contribution plan for the benefit of its employees. Contributions are expensed as they become payable.

Debtors and creditors receivable / payable within one year

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price. Any losses arising from impairment are recognised in expenditure.

Financial instruments

All financial instruments are recognised initially at transaction price excluding transaction costs and subsequently at amortised cost. These include cash at bank, debtors and creditors.
