Para 1.20	<p>Unfortunately many annual events had to be cancelled due to coronavirus.</p> <p>Some events were able to be moved to an online alternative, including a quiz, a wine tasting session and a wreath making workshop.</p> <p>Other events of the year included: Christmas raffle – tickets were sold online and the draw held at school and published online. Christmas trees were sold and delivered to the families of pupils and the local community. Christmas cards and gifts printed with the pupils' festive pictures. School uniform sales.</p> <p>The general support of the PSA continued throughout the covid period, and after an appeal, we were able to provide the school with a marquee for a six month period, with picnic benches, that meant the school had more space to allow for covid restrictions.</p> <p>Other donations to the school included teepees for the lower school playground, an annual donation towards prefect ties for the upper school, and postage for record of achievement letters for each pupil of the upper school.</p>
