The charitable purpose of the group is to provide transport facilities to and from hospital and other medical and care facilities for the benefit of those in need of such services, as described above, together with or in addition to such other charitable services as may in the opinion of the trustees be carried out lawfully and conveniently by the group.

Summary of the main achievements of the charity during the year

In 2025, the Group operated with an average of around 21 volunteer drivers and 2 (later 3) volunteer coordinators.

The Group's volunteer drivers undertook some 1407 drives providing transport facilities to those having need of them, covering a total distance of 39,450 miles.

In addition, around 230 booked drives were subsequently cancelled and there were in excess of 100 requests for which the Group could not meet the need due to a lack of available volunteer drivers.

The trustees wish to record their appreciation for the enormous contribution indicated above in time freely given by all the Group's volunteers. This sentiment is shared by the many clients who express their appreciation directly to the drivers and to the coordinators.
