**Aims and Objectives**

The Weatherley Centre Trust was established for the purpose of providing a centre for the inhabitants of the town of Biggleswade in the county of Bedfordshire and the neighbourhood and for such other charitable purposes for the benefit of the said inhabitants as the Trustees shall in their discretion determine. It is the aim of the Trustee's to oversee the management and control of the Charity, and, to ensure the aims of the Trust are met.
