## Treasurer Annual Report

Jan. 22 - Dec. 22,

As can be seen from the accounts the funding the developer was obliged to give us was received during the year. This replaced the monies we had previously invested in the children's Play Area for the new equipment that was installed. This reinforced what is a very stable financial position as can be seen from the accounts. The changed regulations and qualifications now needed to cut grass has led us to no longer consider doing it ourselves and the decision was made to use professionals. This is an on-going expense but we are able to face this without any problem. A major change is however on the horizon. The building we have used, on an under lease, for changing rooms and toilets will no longer be available in its present form. However it has been agreed we will be able to directly lease a part of the building for changing rooms and toilets. The toilets will in future be available for whatever activities take place on the Playing Field and the constant availability of toilet facilities is a real bonus, as it fills a gap that has always been needed. It has also made the administration of the M.P.F.A. less onerous, which we hope will encourage some new, and younger, volunteers to come forward and join the committee. As things are we are on top of the changes and able to see some progress in the facilities the M.P.F.A. provides.
