Activities

Objects: (1) THE PROVISION AND MAINTENANCE OF A RECREATION GROUND FOR USE BY THE INHABITANTS OF THE AREA OF BENEFIT, WITHOUT DISTINCTION OF POLITICAL, RELIGIOUS OR OTHER OPINIONS (2) THE PROVISION AND MAINTENANCE OF A PAVILION FOR USE BY THE INHABITANTS INCLUDING USE FOR :(A) MEETINGS, LECTURES AND CLASSES, AND (B) OTHER FORMS OF RECREATION AND LEISURE-TIME OCCUPATION, IN THE INTERESTS OF SOCIAL WELFARE WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THE INHABITANTS. (3) THE LAND IDENTIFIED IN PART 1 OF THE SCHEDULE TO THIS SCHEME MUST BE RETAINED BY THE COMMITTEE FOR USE FOR THE OBJECT OF THE CHARITY.

Activities: The provision and maintenance of a recreation ground for use by the inhabitants of the area of benefit, without distinction of political, religious or other opinions. The provision and maintenance of a pavilion for use by the inhabitants including use for: meetings, lectures and classes, and other forms of recreation and leisure-time occupation, in the interests of social welfare.
