Responsibilities and basis of the report

As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ("The Act").

I report in respect of my examination of the Trust's accounts carried out under section of 145 of the 2011 Act and in carrying out my examination I have followed all of the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act.

Treasurer's Report 2020-2021

1. During this pandemic Martin Pickering has kindly been managing the books and paying the bills until our recent lockdown has relaxed and I was able to meet for the official handover.
2. Overview: We have been lucky enough to have been successful with the grants that Dartford Borough Council offered – the Charity Grant, Salute to Youth Grant and the Tier Grants, We have used these funds wisely at the unit for replacing our roof which was in urgent need of attention, re-wiring project that needed to be completed. We have been unable to organise any fundraising activities due to COVID. Our expenditure was at a high cost of £24k but our income was higher and we are able to start 2021 / 2022 on a comfortable opening balance of over £22,000
3. **Income :**
 - a. **Subscriptions:** We offered parents the option to freeze their subscriptions if they were financially unable to afford this and the cadets were not receiving their usual training. Thankfully we have parents still happy to pay. Even though the unit have been successfully training virtually. The number of cadets have decreased with subs from £3,972 to £1,711. With the determination with our change of command I believe we will see our unit grow quickly with the ideas in place.
 - b. **Donations/Fundraising:** There has been no specific fund raising activity during this year due to the COVID and Lockdowns. We have been successful with several grants from DBC for Tier, Charity Grant and Salute to Youth Grant as well as St Michaels Church. We have fulfilled the role of Fundraising Co-ordinator recently and they have great ideas for future funding projects.
 - c. **Course/Uniform:** We have had no expense this year for courses or uniforms.
 - d. **Rent:** We have not been able to sub-let to the boxing club due to the lockdown and no activity at the unit. We hope for them to continue using our unit from the 1st May 2021
 - e. **Miscellaneous:** We have received funds from an insurance claim £2,527.00
4. **Expenditure:**
 - a. **Rent:** Remain the same at £2,750.00
 - b. **Maintenance:** This year we have had major works with re-wiring the offices for safety at a cost of £4,398.54. Replacing the roof on the main deck £9,024 plus asbestos removal £1,891.80 as well as cutting down of dangerous trees £1,250.00. We have replaced fire extinguishers and the maintenance checks £332.31
 - c. **Unit Insurance:** The annual insurance is organised through SCC and at a cost of £748.50. Assets still need to be checked and listed on Westminster correctly before the next premium starts.
 - d. **Stationary:** There has been only a small amount purchased for the year £20.95
 - e. **Water:** This has been an ongoing enquiry with Castle Water with regards to the most recent bills. With a lot of help from our temporary Chairman we have finally come to an understanding with Castle Water that the bills were shockingly high, our water meter has been located. We did have a leak which has now been repaired and we hold £2,517.11 in credit with them which we have requested to be refunded.
 - f. **Electricity:** Due to our unit being closed over the winter I think this may have helped with our lack of electric heating being used. Our direct debits have increased slightly but has left us with a credit of £728.00. I am in contact with them regarding if our account is set up for a charity and to organise a tariff which is cost effective.
 - g. **Gas:** We have not purchased gas this year and received the credit for the duplicate payment made in 2019/2020 £362.87

- h. **Telephone:** The telephone expenditure is still quite high but I believe our officer in charge has organised a cheaper service and hopefully more successful with the internet that we will receive as this has always been a disruption at the unit.
 - i. **Training:** We have had no external training at a cost to the unit. SCC have offered a lot of virtual training with no cost.
 - j. **Boating:** We haven't been able to do due to the restrictions of lockdown.
 - k. **Uniform:** No cost
 - l. **Other:** Adverts placed for recruitment for staff and cadets. £17.50
5. **Summary:** The overall finances of the Unit give us a great start to returning to our activities and going forward for the future we have plans in place for fundraising for a Pontoon for safety for boating and to also work with Gravesend unit as we have the lakes as an advantage. We have new members of the UMT that are challenging different angles going forward for the future and success of our unit for many years to come.
