Respective responsibilities of trustees and examiner

The UMT member appointed will serve until the date of the next AGM, after which the post will be filled by election.

To help young people towards responsible adulthood by encouraging valuable personal attributes and high standards of conduct, using a nautical theme based on the customs of the Royal Navy.

The provision of marine related training and development activities for young people




Public Benefit
