Structure, governance and management

Governing document

The Group's governing document is a lease dated 24th July 1959 upon the trusts of the Boy Scouts Association trust deed 1955.

Governance

The Group is managed by the Group Executive Committee, the members of which are both the 'Charity Trustees' and volunteers of the Scout Group. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

Trustee selection methods

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

The Committee consists of independent representatives, Chair, Treasurer and Secretary together with the individual Section Leaders and parent representation and meets once a month apart from July and December

Risk and Internal Control

The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

- **Damage to the building, property and equipment.** The Group would request the use of buildings, property and equipment from neighbouring organisations such as the church, community centre and other Scout Groups. Similar reciprocal arrangements exist with these organisations. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.
- **Injury to leaders, helpers, supporters and members.** The Group through the membership fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities.
- **Reduced income from fund raising.** The Group is primarily reliant upon income from subscriptions and fundraising. The Group holds a reserve to ensure the continuity of activities should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.
- **Reduction or loss of leaders.** The group is totally reliant upon volunteers to run and administer the activities of the group. If there was a reduction in the number of leaders to an unacceptable level in a particular section or the group as a whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the complete closure of the Group.




EXPLORER REPORT

The last year has seen our Explorer Unit grow and grow, we now have 19 young people with the number expected to increase shortly.

We visited the local RNLI crew at Walmer where their team of volunteers gave the unit a tour of the amazing life saving equipment they have on station including tours of both boats D-Class Duggie Rodbard II & B-Class Atlantic 85 Donald McLauchlan. We also visited Deal Coastguard Rescue Station where the explorers got to try on some of the kit they use for cliff and water rescues while doing some throw line practice and having the dangers around water refreshed in their minds. We have participated in district activities including Op St George and St Georges day parade. And even gone gliding thanks to one of Gavin's Gliding Club.

We were lucky enough that two of our Network Scouts were able to go on a trip to Zanzibar through Kent Scouts - the Explorers assisted with the fundraising activities and were given a talk after the trip about the work they done out there. The two Network Scouts also helped the Explorers complete their International Badge as they have Scouting contacts in Zanzibar!

Now we are afloat again we are working with the young people to further develop their skills and knowledge of power boating, pulling and kayaking. In the last few months of boating we have seen a great improvement in their skills and also their teaching skills as they teach other young people about the activities.

With it being the lead up to camp as I'm writing this we are currently preparing all the boats, engines, kayaks and other equipment including tents to ensure they are ready for a week camping!

I would like to take this moment to say a few thank yous. As most of you are aware mine and Ella's availability since October hasn't been the best and my organisation has been worse than usual... so thank you to Mark, Issak and Nick for mucking in. Thank you to Danny & Gavin for stepping in to the Explorer Leader role again when you didn't have to.

The Explorers themselves need a special thank you, this time last year we had a young group who were unconfident and immature. This past year you have blown me away, with your level of confidence and willingness to help and muck in unprompted. You are becoming young adults and a great role models for your peers. You're a pleasure to have at Lange Wapper and 2nd Deal so thank you!

And lastly I would like to thank 2nd Deal for having us for yet another year!

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's qualified statement
