Respective responsibilities of trustees and examiner

As the charity trustees of the 1st West Wickham Scout Group you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 (The Act), and that an independent examination is needed.

It is my responsibility to:

Basis of independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commissioners. An examination includes a review of accounting records kept by the Group and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required by an audit and, consequently, I do not express an audit opinion on the view given by the accounts.



(i) Basis Of Accounting

The accounts are prepared on the accruals basis of accounting.

The accounts have been prepared under the historical cost convention except for the valuation of investment assets which are shown at market value.
