Report to Parish Council - 18.5.21


The year to 30th April 2021 has been like no other.

This only meeting place in the parish has been silent since March 2020 due to the COVID pandemic.

Despite having no hiring income, the hall has received large sums of Breckland Council Regeneration Grant funding. This has greatly exceeded normal income but the hall has needed much money spent on cleaning and redecoration since the easing of lockdown in readiness for its use as a polling station two weeks ago and to hopefully welcome back the groups who have regularly used the hall in the past.

All policies and assessments and the hire agreement are being reviewed and work is ongoing with the committee working closely with the Parish Council Clerk to ensure compliance regarding areas of public safety and the premises with the added consideration of COVID restrictions.

We have always suffered from very poor drainage as a result of localised flooding, as is usual a few times each year. This always compounds parking difficulties and septic tank issues. The car park surface was stoned to prevent vehicles getting bogged down throughout much of the wetter months in March 2020 and this year has therefore seen an improvement.
