The Covid lockdown restrictions continued for the financial year under review. This limited the charity from being able to carry out any fund raising events, however, throughout the year the open space of the site was made available to the public as a key village green and recreational space. Maintenance of the area continued.

The sports teams met when restrictions allowed, and they provided events to support the residents as well as giving their time to maintain the area. Training for all sports resumed and all three clubs played in their local league matches as allowed.

The Memorial Hall continued to be made available free of charge to a local volunteer group who used the space to sew PPE for the NHS and for overseas countries. The Memorial Hall was also made available to local residents who operated it as a donation and sorting venue for the Ukrainian crisis in the Spring of 2022, providing much needed humanitarian aid.

The Trustees believe that during the continuing pandemic the charity was able to fulfil its obligations to provide facilities for the public benefit as set out in the governing document.

Summary of the main achievements of the charity during the year

Chairperson's Report –Year ended 31st March 2022 AGM 8th August 2022

The Charity was formed 1952. The official name registered with the Charity Commission is 'Memorial Hall and Playing Fields – Middleton Cheney'. We are also known by the working names PFA and Middleton Cheney Playing Fields Association.

The Board of Trustees are responsible for the running of the charity and the safeguarding of its assets. From its conception in 1952 the committee comprises both residents and representatives from the three main sports clubs, Football, Cricket and Tennis.

The field is still one of the main recreational resources for the village, acting not only as a sports field, but also housing a playpark and providing an invaluable open green space for a multitude of uses. During lockdown this resource proved invaluable to the community.

The committee have again seen a number of changes over the last period both within its resident and sports representatives. We currently however have a full committee who have worked to address the many ongoing challenges due to the Covid pandemic. Work has continued in relation to updating policies, bringing our governance practices up to date and working to identify the future needs of the hall, pavilion, and field.

We have been very fortunate to have received several Government backed Covid Grants to support us through the pandemic. Without this support our finances would have been disastrous. Regrettably a number of our regular Hall hirers did not survive the pandemic which has left us with drop in annual income.

Sport has continued and all three clubs have managed to both provide sports opportunities to the local residents and support the Charity through their rental contributions.

Short term considerations

Our short term goals are still to keep the facility open and available to all those that wish to use it and to continue with small refurbishment projects. With that in mind we hope our first project will be the updating of the hall toilets and installation of a disabled toilet facility. We hope with a more welcoming space we can increase the number of hall users again. We are also looking at ways in which we can help those sports clubs that operate from the ground, both in terms of facilities and security.

Medium term considerations

In the mid term we are still looking at the funding options available to complete larger scale refurbishment works or maybe even rebuild. A systematic rolling programme of maintenance is still being followed. The committee are very well aware that the main building especially is old and therefore by nature not very energy efficient. With the new challenges of rapidly increasing fuel prices we need to look to see how we can make the building more sustainable going forward. The committee are also looking at encouraging more events back onto the field. Traditionally the Charity held a main fundraiser each year and we are looking to hold something similar again.

As a committee we are encouraging cross sport participation in the ongoing maintenance and use of the open space. We are continuing to focus on the best way to utilise the funds we have for the future of the charity. The COVID grant funding has been essential in enabling us to ring fence reserves to protect the financial position of the charity going forward.

Long term considerations

The buildings as they stand require substantial amounts to be spent to upgrade them and to ensure they meet expectations of current and potential users. We are wary of spending our funds impulsively as our aim for the future is to provide an improved building. We have invited residents to join us on a working party to look at all the options available to us and to determine whether a refurbishment or rebuild would be the best solution, and how to proceed. We welcome input and ideas and are looking for volunteers to become actively involved. Rebuilding the hall is not a new idea by any means and over the years there have been various proposals and plans drawn up. These will be revisited, and a new approach found. This will need to be considered

alongside a concerted fundraising effort. A solution may be expensive, but it is necessary if we are going to have a facility which will serve the village for the long term. A strong and determined team will be needed to then take the facility forward and make it sustainable for the next generations with a sound business plan in place. Long term therefore we are looking at the challenges of the increasing overheads and sustainability. We are aware that the site is landlocked and therefore expansion is difficult. We are aware that football have 'outgrown' the site and we need to see how we can support them going forward. The village itself has also grown and it still seeing annual housing development with another 150 houses coming in the next year. Therefore, we need to look at the purpose of the facilities going forward with a growing population and what is needed in the village by those residents. There is a lot of work and research to be done into funding options both immediately for any project and then going forward in terms of a secure business plan.





**Chairperson's Report –Year ended 31st March 2021
AGM 9th August 2021**

The Charity was formed 1952. The official name registered with the Charity Commission is 'Memorial Hall and Playing Fields – Middleton Cheney'. We are also known by the working names PFA and Middleton Cheney Playing Fields Association. The Board of Trustees are responsible for the running of the charity and the safeguarding of its assets.

From its conception in 1952 the committee comprises both residents and representatives from the three main sports clubs, Football, Cricket and Tennis. The field is still one of the main recreational resources for the village, acting not only as a sports field, but also housing a playpark and providing an invaluable open green space for a multitude of uses. During lockdown this resource proved invaluable to the community.

The current committee took office in November 2020 and there have been many challenges due to the Covid pandemic, however, much work has been taking place which may not always have been visible to the public. We have been updating policies, bringing our governance practices up to date and working to identify the future needs of the hall, pavilion, and field. A new website and email system is in progress to facilitate better communication both within and outside of the committee.

We have been fortunate to have received several Government backed Covid Grants to support us through the pandemic. Without this support our finances would have been precarious. The lockdown restrictions came into force just a few months after losing the regular income from the use of the Memorial Hall by the Social Club, which ceased trading in January 2020. The sports clubs continued to pay their rent which was a welcome inflow of funds.

Short term considerations

We hope that, as restriction ease, we will be welcoming back regular community hirers of the Memorial Hall. It is not practical currently to reopen the bar or to put in place those works needed to hire the venue out for larger events and parties.

Medium term considerations

We have spent some funds on modest essential improvements, and requirements for reopening. A systematic rolling programme of maintenance needs to be instigated. We are focusing on the best way to utilise the funds we have for the future of the charity. The grant funding has enabled us to ring fence reserves to protect the financial position of the charity going forward.

Whilst we have a great team of grounds persons that look after the field, we aim to consider the boundaries and other spaces available to us to determine what improvements we can achieve. Ideas such as wildflower areas, improved hedgerows and tidying the boundaries have been suggested.

Long term considerations

The buildings as they stand require substantial amounts to be spent to upgrade them and to ensure they meet expectations of current and potential users. We are wary of spending our funds impulsively as our aim for the future is to provide an improved building. We have invited residents to join us on a working party to look at all the options available to us and to determine whether a refurbishment or rebuild would be the best solution, and how to proceed. We welcome input and ideas and are looking for volunteers to become actively involved. Rebuilding the hall is not a new idea by any means and over the years there have been various proposals and plans drawn up. These will be revisited, and a new approach found. This will need to be considered alongside a concerted fundraising effort. The Committee have discussed the most appropriate Reserve Policy for the charity, and it is considered that an appropriate level is the amount required to cover twelve months usual running costs of the charity.
