Works were carried out to replace the railings around the perimeter of the hall and general maintenance carried out.

New tables were purchased.

A pre school now uses the premises on a regular basis providing a steady income.

No specific fundraising took place this year 2020/2021 due to covid restrictions but these would usually include quiz nights, suppers and dances.
