Governance

Tatworth Memorial Hall is a registered charity which was established by a Trust Deed dated 5 July 1952. The Trust Deed is held, together with other important documents, by our solicitors. The Hall was opened in 1953 and was extended and refurbished in 2001 with help from the National Lottery, Somerset County Council, South Somerset District Council, The Countryside Agency, Tatworth and Forton Parish Council and many private donations. The Hall and land are held in trust on behalf of the Parish by the trustees who are responsible for the management of the Hall, its finances and for keeping the building in a good state of repair. The Hall comprises the main hall, kitchen, foyer, Cozens' Room and bar, the Brewer and Stonham Rooms and the Parish Council Office in the Hoskins' Annexe, storerooms, toilets and car park. The children's play area and adjacent land are leased to Somerset Council to provide a children's centre and/or use by a pre-school.

Appointment of Trustees

The Trust Deed governs the appointment of trustees and the management of the charity. Seven trustees are elected at the Annual General Meeting held each year. In addition, eight local organisations have the right to nominate a trustee. Each trustee serves for a period of one year and may be re-appointed. The trustees form the Management Committee of Tatworth Memorial Hall which has the power to co-opt up to two further trustees. The Management Committee meets 6 times a year.

Objectives of the Charity

The Trust Deed requires the charity to provide "physical and mental training and recreation and, social, moral and intellectual development through the medium of reading and recreation rooms, library, lectures, classes, recreation and entertainment or otherwise as may be found expedient for the benefit of the inhabitants of Tatworth and Forton and its immediate vicinity without distinction of sex, of political, religious or other opinions'.

Principal Activities in pursuit of Objectives

The Hall is used almost every day of the year for a variety of activities associated with the Parish's many clubs and societies, the Parish Council and private hirings.

Hiring Agreement

Use of the Memorial Hall is subject to a Hiring Agreement which must be signed by the hirer when booking. This agreement sets out the conditions of hire and forms a contract between the parties setting out their respective responsibilities. This is an essential requirement of the Hall's insurance policy.

Licences

The Hall has a premises licence issued by South Somerset District Council governing the provision of entertainment to the public and the sale and supply of alcohol. The licence is held by the trustees who are collectively responsible for its administration. The Hall is registered with the Information Commissioner's Office. The hall is registered with SSDC under the Food Hygiene Regulations 2004 and has received a "5" grading, the highest.

Risk Management

The Management Committee recognises that it is under a legal obligation to protect the building, its hirers and employees through adequate and appropriate insurance.

The Hall is insured with respect to property damage (buildings insurance) by Allied Westminster Insurance Services Ltd (Sum assured: £912,675). It is insured with the same company with respect to contents (£36,311), public liability (£10 million), employer's liability (£10 million), trustee indemnity (£250,000) and legal expenses (£100,000).

Subject to certain conditions, hirers who have no public liability cover of their own are included under the Hall's public liability insurance to a maximum of £2 million. The cover does not extend to commercial hirers.

Maintenance Matters

Gas appliances and portable electrical appliances are tested by qualified personnel periodically as required by law.

The electrical circuitry is tested by a qualified electrician every five years.

Safety and Fire Risk Assessments are carried out regularly.

Fire fighting appliances (annually) and Fire Alarms system (6 monthly) are inspected and serviced.

Trustees carry out regular maintenance checks and hirers are required to note any faults or defects in the maintenance book which is checked regularly by the committee.

Hirers are required to record all accidents in the Accident Record Book.

Financial Strategy

The trustees have agreed Financial and Investment Policies which set out their responsibility for the prudent management of Hall funds. It is the objective of the trustees to set hire charges at a level which ensures the basic running costs of around £400 per week are met. Any surplus is transferred to the reserves. In 2003 the Memorial Hall received a legacy of £100,000 from the will of Jack Stonham, a resident of the parish. The purpose of this legacy is to improve the fabric of the hall and its facilities. Trustees have agreed a formal investment policy for the fund which aims to establish a long-term building fund and a medium-term repair fund to meet the cost of major repair and renovation of the existing building. These investments are managed by Rathbone investment Management Ltd and held in appropriate Rathbone funds.

Volunteers' Efforts

The running costs of the Hall are kept as low as possible by voluntary work of the trustees and others. In addition, the Hall has the services of a cleaner, a caretaker and the occasional handyman. On average 40 hours of trustee and other volunteers time are given each week to cover routine tasks such as repairs, renewals and maintenance matters, bookings, processing payments, correspondence, Management Committee administration, fund raising, and hirer enquires. A considerable amount of trustees' time is devoted in dealing with the ever-increasing burden of compliance with charity law and regulations and health and safety legislation governing community buildings.

Achievements and Setbacks

The trustees work hard to make the Hall attractive to hirers and measure their success by the range of users and the Hall occupancy. Revenue rose significantly from an increase in casual lettings and a change in pricing so all users now pay the same rates. The letting income increased to £15,635 (2023 £9,910)

No renovations were carried out, the largest repair expenditure was the cost of Pollarding a tree for the safety of the pre-school and the 5 year electrical inspection. During the year and total costs were around £22,000.

The Hall had to pay the full costs of the much higher energy costs, a result for the war in Ukraine. The energy costs for the year were £9,909 (2023 £3,999) a substantial increase as forecast.

The regular monthly film show finished in April 2023. It had raised many thousands of pounds over the years in support of the Hall.

Achievements

- The Hall made a small surplus in the year.
- The Solar panels have provided the hall with some free electricity.
- A youth club ran during the year, funded by the Parish Council.
- A security lock was fitted to the main door.
- Security cameras were fitted to observe both entrances.
- A monthly Bingo has been run for the year and raised over £3,500 for Hall funds.

Overall View of the Year and Future Plans

The overall financial position of the Hall remains satisfactory, and the accounts show a small surplus for the year. The investments have recovered the losses suffered in the previous year. The rates charged for the Hall hire were reviewed and simplified from the 1 April 2023 most users accepted the increases which resulted from these changes, all users now pay the same rate.

Future Plans

The current squeeze on living standards and the uncertainty caused by the general election it is difficult to plan with any confidence. A project that will be looked at in the coming year is the most efficient and cost-effective way of heating the Hall.

Acknowledgements

The trustees would again like to thank the residents of Tatworth and Forton for their support of the Hall. Many Hall bookings come from the parish and its many and various clubs, societies and organisations. Unlike many village halls the Hall does not receive regular grant support towards running costs and must be self-supporting. Thanks go to the late Nan Austin a long-standing supporter of the Hall whose funeral retiring collection was left to the Hall. We are also grateful for the support and help given in running monthly fund-raising bingos.

The trustees would like to thank our caretaking team of Eric Peadon and Holly Lewis for their efforts in keeping the Hall and grounds in good order and ensuring a welcoming environment for hirers. We would also like to express our thanks for the support of the Parish council.



This year has marked a gradual return of activities following the Government's suspension of gatherings and the restrictions on social distancing due to the pandemic.

Hiring Agreement

Use of the Memorial Hall is subject to a Hiring Agreement which must be signed by the hirer when booking. This agreement sets out the conditions of hire and forms a contract between the parties setting out their respective responsibilities. This is an essential requirement of the Hall's insurance policy.

Licences

The Hall has a premises licence issued by South Somerset District Council governing the provision of entertainment to the public and the sale and supply of alcohol. The licence is held by the trustees who are collectively responsible for its administration. The Hall is registered with SSDC under the Food and Hygiene Regulations 2004 and has received a "5" grading, the highest.

Risk Management

The Management Committee recognises that it is under a legal obligation to protect the building, its hirers and employees through adequate and appropriate insurance.

Financial Strategy

In 2003 the Memorial Hall received a legacy of £100,000 from the will of the late Jack Stonham, a resident of the parish. The purpose of this legacy is to improve the fabric of the Hall and its facilities. The fund has been managed cautiously to maximise the income in the currently prevailing climate of low interest rates. Trustees have now agreed a formal investment policy for the fund which aims to establish a long-term building fund to prepare for the eventual capital cost of a new Hall and a medium term repair fund to meet the cost of major repair or renovation of the existing building. These investments have been made in growth funds with Rathbone Investment Management Ltd.

Volunteers' Efforts

The running costs of the Hall are kept as low as possible by the voluntary work of trustees. In addition the Hall employs a cleaner, a caretaker and the occasional services of a handyman. On average 40 hours of trustee time are given each week to cover routine tasks such as repairs and renewals, painting and refurbishment, bookings, processing payments, correspondence, Management Committee administration, maintenance matters, fund raising and

hirer enquiries. A considerable amount of trustees' time is devoted to dealing with the ever increasing burden of compliance with charity law and regulations and health and safety legislation governing community buildings.

Achievements and Setbacks

The trustees work hard to make the Hall attractive to hirers and measure their success by the range of users and the Hall occupancy. Revenue from hirings has increased in the year under review from £5,108 to £9,069. Although a considerable increase on the previous COVID year it is still well below the norm. The Hall received continuing support from the Government's COVID Business Recovery Grant Scheme of almost £12,000. Total expenditure remained constant at around £20,000. Energy costs fell slightly from £2,942 to £2,733. Water and sewerage have shown an increase from £210 to £463.

Achievements

- A small surplus of income over expenditure of approximately £6,000 was achieved
- New curtains were installed in the main hall and Cozens' Room
- A new dishwasher was purchased (for which a grant of £400 was received from the Parish Council)
- Regular audits of electricity and water consumption are undertaken
- The monthly film shows organised by the trustees and volunteers were resumed in January
- The paperback book exchange in both foyers continues to be very popular and provides useful income
- The taps in the Ladies' toilets have been replaced with water saving models
- The toilet seats in the Ladies have been replaced with a more substantial and easily cleaned design

Overall View of the Year and Future Plans

The overall financial position of the Hall remains satisfactory and the accounts show a surplus of income over running costs. There are substantial sums invested to meet an ongoing programme of improvements and any unforeseen disasters. Hire charges remained unchanged for regular users for the 15th year in succession.

Future Plans

As this report concludes at the end of March 2022, the country is recovering from two lockdowns and other restrictions due to the Coronavirus pandemic. The Hall's business is also in a state of recovery. The Hall's investment portfolio with Rathbone Investments has rallied but the future is still uncertain due to stock market volatility in the current global economic climate. This prevailing uncertainty has meant that trustees are reluctant to commit to a programme of renewals and enhancements until revenue stabilises.





Introduction

The year 20/21 was an unprecedented period for the Hall because of the COVID-19 pandemic. Activities were extremely limited and for this reason this Annual Report is necessarily brief.

Governance, administrative and legal parameters have not changed from those detailed in previous Annual Reports.

Overall View of the Year

Although the Hall remained open throughout the year under review, Government restrictions on numbers and social distancing prevented almost all our users from meeting. Income from hirings was only a small fraction of normal. The trustees are very grateful to Wendy's Kitchen Take Away and Delivery Service, Tatworth and Forton Parish Council, Somerset Social Care and Mr. Griminger's Podiatry C2linic for continuing to hire the Hall albeit less frequently. A reduction in use did not unfortunately result in an equivalent reduction in running costs of around £1000 a month which still had to be met. However it was necessary and desirable to retain the services of our caretaker and cleaner throughout the year to ensure, as far as possible a COVID secure environment. The trustees would therefore like to thank Eric Peadon and Holly Lewis for their work in very difficult circumstances.

The trustees acknowledge that without receipt of HMG Small Business Recovery Grants of £20,000 the Hall would have been in considerable financial difficulty. Unless business recovers in the coming year this financial uncertainty remains. The long term investments with Rathbone Brothers after falling sharply have now recovered.

Achievements

Achievements have been necessarily limited. However it has been possible to do the following:

- Replace the oven with a larger range cooker (for which a grant of £400 was received from the Parish Council)
- Replace flooring in the Gents' toilets
- Replace the central heating boiler with a more energy efficient model
- Complete the installation of LED lighting in the Hoskins' Annexe
- Replace the toilet seats and taps in the ladies' toilets

Future Plans

As this report concludes at the end of March 2021, the future is still uncertain. It is therefore impossible to plan for the future with any confidence.

The trustees declare that they have approved the trustees' report above.
