As requested I attach the following report for your records. The Burstall Village Hall Charity holds no financial assets still only the property known as Burstall Village Hall. Under the Trust Deed the property is managed by the Burstall Village Club on its behalf and activity has been very curtailed in the past year owing to the grounds and Village Hall itself being closed under covid restrictions. The property itself is in good order with some minor repairs being carried out during the year particularly to the clock tower. No fundraising events have been able to be held for both 2020 and likewise 2021 in particular the annual Burstall Village Show which is our main fundraiser. Resources are adequate within its Burstall Village Club account to maintain its capability for maintenance and minimal running repair costs until the covid restrictions are lifted. The benefit from the charitable funds will then be capable of continuing its support to organisations in the village of Burstall.
