INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF THE WHITE HART BARN


Independent examiner's statement

1 ACCOUNTING POLICIES

General

These accounts have been prepared under the historical cost convention and in accordance with applicable accounting standards and the Statement of Recommended Practice on Accounting for Charities using the Receipts and Payments method.

Fixed Assets

The White Hart Barn is shown at its 2016 valuation adopted for insurance purposes. All fixtures are included within this valuation. Furniture is expensed in the year it was incurred.

Depreciation

Land, Buildings and Fixtures: No depreciation is provided on the building as any replacement or improvement will be funded in the year it is incurred.

General Fund

The General Fund is unrestricted and can be used for activities carried out by the trustees of the White Hart Barn.
