## Objectives and activities

---

Summary of the objects of the group set out in its governing document      The objectives of the group are as a unit of the Scout Association.

The aim of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potential, as individuals, as responsible citizens and as members of their local, national and international communities. This aim is achieved by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

Summary of main activities

St Nicolas 9th Guildford Scout Group is run and managed by unpaid volunteers and offers a wide programme of activities to young people aged 6-18. There are 4 sections: Beavers (age 6-8), Cubs (8-10), Scouts (10-14) and Explorers (14-18). The Explorer Scout Unit (ESU) was set up in 2014 and has a Partnership Agreement with the main group. This Annual Report covers all four sections of the group, including the ESU.

The group is very grateful for the support of the Guildford United Reformed Church, which grants the use of its lower hall for meetings.

## Achievements and performance

---

Main achievements during the year

**Group:** Once again, we have run a full programme of activities across all four sections and we continue to have no problems in recruiting young people and currently hold waiting lists for a couple of sections. Sadly Josh Goodwin stepped down as GSL this year. We have not been able to recruit a replacement but he is a very hard act to follow. Also, Angie Lee stepped down from leading the Scouts section in March leaving another huge gap. Recruitment of new leaders is very much the priority for 2025-2026 and also ensuring that the Trustee Board supports and values all of our adult volunteers. Thankfully, the Trustee Board remains strong. This is the first full financial year since the pandemic without any exceptional payments and the accounts look robust with an increase in reserves of over one thousand pounds. This was boosted though by an equipment grant from Thames Water. We continue to monitor subscriptions and payments closely. In conclusion, a good year financially but we do need to boost volunteers to ensure we can continue to provide a full programme of activities across all four sections.

**Beavers:** Last year was packed with exciting activities for our 24 Beavers, who earned many badges, for example, the Builder, Disability Awareness, Emergency Aid, and Experiments badges. Highlights included a visit to Disability Challengers in Stoke Park, attending the District Activity Afternoon in Normandy, taking part in Survival Camp, and participating in parade services at St Nicolas' and the URC. More recently, the Beavers have chosen to work towards the Space badge and will also complete the International badge with activities like a Spanish-themed evening. They have participated in junk modelling, making autumn crafts, and preparing for the next Survival Camp. Badge goals include Cook, Gardener, Communicator, and Global Issues, with exciting events like the District Sleepover at Winchester Science Centre, a Mothering Sunday parade at St Nics, and a lively Burns Night celebration. Our leadership team remains strong, with BSL, ABSL, Section Assistants Enric and Lyndsey, and (hopefully) Sarah Birch joining us soon. We're also been supported this year by Young Leader Thomas Carter and DofE helpers Jamie McGowan, Alexandra Williams, Sophie Blake, and Emily Scott.

**Cubs:** Over the past year, the Cubs have enjoyed a full and varied programme, with membership remaining strong and currently standing at 30 cubs. Despite Akela being on sabbatical for parts of the year, the section was ably led by a dedicated team of leaders, section assistants, and three enthusiastic Young Leaders. Cubs took part in a wide range of indoor and outdoor activities, including hikes at Blackheath, pond dipping, gardening, kite making, water games, and a visit to the Spike. They explored community topics through first aid training, learning about local services like the food bank and the police, and participating in parades and remembrance activities. Highlights included attending District and Survival Camps, and preparing for a delayed "summer" camp at Broadstone Warren in October. Cubs also completed badge work such as Gardener, Money Skills, and Emergency Aid 2, and took part in competitions, quizzes, and themed meetings like the popular "Cubs' Choice" night.

**Scouts:** Over the past year, the Scout troop has seen a dynamic and eventful calendar, growing from 32 to 42 Scouts, with a girl-to-boy ratio averaging around one-third girls. The troop welcomed several new members from the waiting list and from cubs, while also noting a younger demographic due to the lingering impact of COVID-19 on older Scouts' progression. Throughout the year, Scouts participated in a wide range of camps and events, including County Expedition Challenges, Kip 'n Kayak, Scoutabout, and the International Jambowlree. They earned a remarkable 349 badges collectively, including a Chief Scout's Gold Award and new Nights Away woggles. Activities followed a 'Skills for Life' theme, with events like Scout Skills, Camp Skills, and several badge-focused camps. Notable achievements included outstanding performance in expedition challenges, and the continuation of a strong link with the Explorer unit for Bronze DofE preparation. Sadly, Hathi stepped down as leader in March 2025. Fergus Bell and Rainer McGill have stepped up in the interim as the Group as a whole works out how best to progress with the Scout section.

**Explorers:** The Explorer unit continues to run a weekend programme, focussed on outdoor activities and expeditions. We have 32 Explorers and 3 Leaders. Some other local Explorers join our Bronze DofE expeditions and other events. We have also invited St Nicolas 9th Scouts to some events and participated in Onslow Infants and St Nicolas Church summer fairs to promote the Group and support volunteer recruitment.

**Leadership:** Peter and Jonathan are joint Leaders, supported by Jenna, plus Kim who manages the Explorers and DofE administration.

We continue to attract new Explorers from other local Scout troops, which do not have their own Explorer sections.

The Group Executive Committee considers that the group should hold a sum equivalent to 2 to 6 months' running costs, being £2,000 - £6,000.


The Group held reserves of £10,241.72 at year end (2024: £9,224.13) which is higher than the group's policy.







**Structure, governance and management**

---

**Description of the charity's trusts**

Type of governing document The Group's governing documents are those of the Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and the Policy, Organisation and Rules of the Scout Association.

How the charity is constituted The Group is a trust established under its rules which are common to all Scouts.

Trustee selection methods The Trustees are appointed in accordance with the Policy, Organisation and Rules of the Scout Association.

## Objectives and activities

---

Summary of the objects of the group set out in its governing document The objectives of the group are as a unit of the Scout Association.

The aim of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potential, as individuals, as responsible citizens and as members of their local, national and international communities. This aim is achieved by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

Summary of main activities

St Nicolas 9th Guildford Scout Group is run and managed by unpaid volunteers and offers a wide programme of activities to young people aged 6-18. There are 4 sections: Beavers (age 6-8), Cubs (8-10), Scouts (10-14) and Explorers (14-18). The Explorer Scout Unit (ESU) was set up in 2014 and has a Partnership Agreement with the main group. This Annual Report covers all four sections of the group, including the ESU. The group is very grateful for the support of the Guildford United Reformed Church, which grants the use of its lower hall for meetings.

## Achievements and performance

---

Main achievements during the year

**Group:** We have run a full programme of activities across all four sections. We have no problems in recruiting young people and currently hold waiting lists for a couple of sections. We would like to recruit more leaders, especially Explorers and Scouts. Angie Lee has very ably stepped up to run the Scout section and we have recruited some new cubs assistant leaders to take her place. The Trustee Board is strong but we could always do with more representatives. Since the pandemic, we have yet to have a full financial year without any exceptional payments. Last year we ran to a deficit of over three thousand pounds so we increased the termly subs amount for the first time in ten years. Our deficit for this year is less at just over one thousand pounds. Next financial year we will have a full year of the increased subs, so should finish the year in credit and can fully evaluate our finances post-pandemic. Overall a good year on which to form the foundations of next year.

**Beavers:** Last year I was pleased to report that we had awarded 256 badges - this year it's 345! This included 13 Chief Scout Bronze Awards, the highest award that we aim for every Beaver to achieve by providing a broad and balanced programme. They worked on the Builder, Communicator, Cook, Disability Awareness, Experiment and Navigator badges. We visited Disability Challengers in Stoke Park, found our way through the maze and along the Nightline at Walton Firs, enjoyed Survival Camp with the rest of the Group and danced vigorously with a Scottish country dancing teacher to celebrate Burns' Night, as well as the usual crafts and games. All this has been achieved with our Leadership Team (4 now in uniform) and young leaders and Duke of Edinburgh helpers. Here's to another busy year!

**Cubs:** Currently 32 Cubs, 11F 21M with numbers moving on to Scouts replaced by Beavers moving up, so no spaces. For Monday meetings we usually have 2 leaders plus one SA, and 3 YLs. We also have 3 SAs for weekend activities. However for the Summer Term 24 Akela is on sabbatical so the meetings are being run by the other leaders.

We had a full programme through the year, with Cubs taking part in 4 camps plus Family Camp, and our 'Summer' camp 24 is in early Oct at Broadstone Warren. The programme and subs are now on OSM. Large numbers of badges have been gained through the year with ten Cubs earning their Chief Scouts Silver Jan 23 to Jan 24 and 3 more since then.

**Scouts:** We ended the financial year with 35 Scouts; 22 boys and 13 girls. We have been able to invite some new members to join from the waiting list, but this is now on pause as we're due to have 40 Scouts this September and potentially 50 Scouts in 2026!

The Leadership team was joined by Angie Lee (Hathi) in September, but unfortunately at the same time we lost one of our Assistant Leaders, Jemma Holloway, who has moved to 1st Chiddingfold Scout Troop following a house move.

Over the year the Scouts earned 460 badges, including four Chief Scout Gold Awards, one Silver Dragon Award and five Bronze Dragon Awards. Between them the Scouts took part in 211 nights away and we've now awarded two of our new 50 Nights Away woggles and three of the 25 Nights Away woggles. We've also discovered a few new badges, including the SubZero badge and the Scottish Zodiac awards, which the Scouts are now working towards.

We have continued with our weekend, outdoor-focused programme, with highlights from the past year including a trip to the Netherlands with other troops from our District, another great Christmas dinner camp with the Explorers (when all attendees earned the SubZero badge!) and Frost Camp in February (which was relatively warm!).

Last September our older Scouts (those in Year 9) were invited to start their Bronze Duke of Edinburgh Award with the Explorers, whilst still remaining a part of the Scout troop. This worked very well as they were able to progress their own skills whilst still supporting the younger Scouts and developing their leadership skills.

We practised our navigating in the Spring term; navigating across Guildford, across the North Downs and across London. It was our first time taking the Scouts on the Monopoly Run and, as well as being great fun, it was a great chance for the Scouts to learn about navigating in a city. It's not what would usually come to mind when you think about Scouts and navigating, but being able to read the tube map, navigate the underground and knowing how to find a bus stop are all definitely skills for life!

**Explorers:** The Explorer Unit has continued its weekends only, outdoors and expedition focussed programme. We have 31 Explorers and 4 leaders.

**Leadership:** Peter, Jonathan (joint leaders), Jenna, plus Kim running admin and DofE. We have Scouts and Explorers from other local troops taking part in some of our events, including our DofE bronze programme.

### Policy on reserves




As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ("the Act").


