Objects: (A) TO APPRENTICE YOUNG PERSONS UNDER 25 YEARS OF AGE WHO ARE RESIDENT IN THE PARISH OF LYDUNCH WHO ARE IN THE OPINION OF THE TRUSTEES IN NEED OF FINANCIAL ASSISTANCE, TO SOME USEFUL TRADE OR OCCUPATION; (B) TO PROVIDE FINANCIAL ASSISTANCE, OUTFITS, CLOTHING, TOOLS, INSTRUMENTS OR BOOKS TO ENABLE BENEFICIARIES ON LEAVING SCHOOL, UNIVERSITY OR ANY OTHER EDUCATIONAL ESTABLISHMENT TO PREPARE FOR, OR ASSIST THEIR ENTRY INTO A PROFESSION, TRADE OR CALLING; (C) TO AWARDING TO BENEFICIARIES SCHOLARSHIPS, GRANTS OR MAINTENANCE ALLOWANCES TENABLE AT ANY SECONDARY SCHOOL, COLLEGE OF EDUCATION, UNIVERSITY OR OTHER INSTITUTION OF FURTHER (INCLUDING PROFESSIONAL AND TECHNICAL) EDUCATION APPROVED BY THE TRUSTEES; AND (D) TO OTHERWISE PROMOTE THE EDUCATION (INCLUDING SOCIAL AND PHYSICAL TRAINING) OF BENEFICIARIES.
