PROVIDING FINANCIAL ASSISTANCE, OUTFITS CLOTHING TOOLS, INSTRUMENTS OR BOOKS TO ENABLE BENEFICIARIES TO PREPARE FOR OR TO ASSIST THEIR ENTRY INTO A PROFESSION, TRADE OR CALLING. 3. OTHERWISE PROMOTING EDUCATION INCLUDING SOCIAL AND PHYSICAL TRAINING OF BENEFICIARIES, PROVIDED THAT 5 PER CENT OF NET ANNUAL INCOME SHALL BE APPLIED IN AWARDING "NORMAN PRIZES" OR FOR ANY OTHER PURPOSE TO ANY EDUCATIONAL FACILITY IN EDENBRIDGE.

**Activities:** Promoting Education including social and physical training of beneficiaries and awarding prizes and supporting educational facilities in Edenbridge.
