There is an overall decrease this year of £17334.60.

Due to the on-going Covid-19 pandemic a significant drop in overall income has led to the deficit this year. The main changes are:

A decrease in DCC/SEN vouchers	£9880.11-
A decrease in Fees	£7671.38-
A decrease in Raised Funds	£2220.87-

Whilst most expenses have had small increases. The fencing has been renewed and the building extended, this has resulted in a large outlay of funds. The main changes have been in the following:

A small increase in Wages	£722.85
A large increase in Maintenance	£29291.11
A small decrease in Clean	£160.91-
A decrease in playroom equipment	£403.34-

The Balance at the end of 2020 is £63280.14

The accounts have been well prepared and are an accurate reflection of the playgroup finances.


