Objects: 1) PROVISION OF A SCHOOL SITE 2) TO ADVANCE THE EDUCATION OF THE PUPILS AT THE SCHOOL BY ASSISTING IN THE MAINTENANCE OF THE SCHOOL AND THE PROVISION OF FACILITIES NOT REQUIRED TO BE PUBLICLY FUNDED FOR EDUCATION AT THE SCHOOL 3) TO ADVANCE THE EDUCATION OF PERSONS UNDER THE AGE OF 25 YEARS RESIDENT IN THE PARISH OF CHEW STOKE AND WHO ARE IN NEED OF FINANCIAL ASSISTANCE AND THE PROVISION IN THE INTERESTS OF SOCIAL WELFARE OF FACILITIES FOR RECREATION AND OTHER LEISURE-TIME OCCUPATIONS TO ENABLE SUCH PERSONS AS TO DEVELOP THEIR PHYSICAL, MENTAL AND MORAL CAPABILITIES THAT THEIR CONDITIONS IN LIFE MAY BE IMPROVED.

Activities: Chew Stoke C of E Primary School was created in 1718, with an endowment from local landowners; it was renamed Chew Stoke Church School (An Academy) when it converted to academy status with effect from 1 September 2012. The trustees of Chew Stoke Educational Trust administer the endowment for the benefit of the school.
