Objects: PROVISION OF A YEARLY SUM FOR THE BENEFIT OF A CLERGYMAN'S WIDOW RESIDENT IN EITHER OF THE DIOCESES OF NORWICH OR ST EDMUNDSBURY AND IPSWICH.PROVISION OF A YEARLY SUM TOWARDS THE MAINTENANCE OF THE SCHOOL PREMISES. APPLICATION OF A YEARLY SUM, NOT EXCEEDING ONE THIRD OF NET INCOME, FOR PROVIDING SPECIAL BENEFITS FOR THE SCHOOL. RESIDUE OF THE NET YEARLY INCOME SHALL BE APPLIED AS FOLLOWS:(A) IN AWARDING TO BENEFICIARIES EXHIBITIONS TENABLE AT ANY SECONDARY SCHOOL, TRAINING COLLEGE FOR TEACHERS, UNIVERSITY, OR OTHER INSTITUTION OF FURTHER EDUCATION;(B) IN PROVIDING FINANCIAL ASSISTANCE, OUTFITS, CLOTHING, TOOLS, INSTRUMENTS OR BOOKS TO HELP BENEFICIARIES ON LEAVING SCHOOL, UNIVERSITY OR ANY OTHER EDUCATIONAL ESTABLISHMENT, TO PREPARE FOR, OR TO ENTER, A PROFESSION, TRADE OR CALLING;(C) IN OTHERWISE PROMOTING THE EDUCATION(INCLUDING SOCIAL AND PHYSICAL TRAINING) OF BENEFICIARIES. BENEFICIARIES MEANS PERSONS OF EITHER SEX WHO HAVE NOT ATTAINED THE AGE OF 25 YEARS, WHO ARE RESIDENT IN THE PARISH OF LAXFIELD OR WHO ARE, OR HAVE FOR A PERIOD OF NOT LESS THAN TWO YEARS AT ANY TIME BEEN, IN ATTENDANCE AT THE SCHOOL AND WHO ARE IN NEED OF FINANCIAL ASSISTANCE.
