**Objects:** THE GOVERNORS SHALL FIRST DEFRAY OUT OF THE INCOME OF THE CHARITY THE COST OF MAINTAINING THE PROPERTY OF THE CHARITY (INCLUDING THE REPAIR AND INSURANCE OF ANY BUILDINGS THEREON) AND ALL OTHER CHARGES AND OUTGOINGS PAYABLE IN RESPECT THEREOF AND ALL THE PROPER COSTS, CHARGES AND EXPENSES OF AND INCIDENTAL TO THE ADMINISTRATION AND MANAGEMENT OF THE CHARITY. (1) SUBJECT TO PAYMENT OF THE EXPENSES AFORESAID THE GOVERNORS MAY APPLY NOT MORE THAN £1,000, OR SUCH OTHER SUM AS THE COMMISSIONERS MAY APPROVE, IN ANY YEAR IN MAKING PAYMENTS TO THE SCHOOL GOVERNORS OF ANY VOLUNTARY AIDED SCHOOL IN THE AREA OF THE FORMER MUNICIPAL BOROUGH OF CHELMSFORD IN WHICH RELIGIOUS INSTRUCTION IS GIVEN IN THE DOCTRINES OF THE CHURCH OF ENGLAND TOWARDS MEETING THE SCHOOL GOVERNORS' OBLIGATIONS IN RESPECT OF THE MAINTAINANCE, IMPROVEMENT OR ADDITION TO SCHOOL PREMISES. (2) SUBJECT THERETO THE GOVERNORS SHALL APPLY THE INCOME OF THE CHARITY IN ONE OR MORE OF THE FOLLOWING WAYS: (A) IN PROVIDING SUCH SPECIAL BENEFITS OF ANY KIND NOT NORMALLY PROVIDED BY THE LOCAL EDUCATION AUTHORITY AT ANY SCHOOL OR COLLEGE IN THE MAINTAINED SECTOR CATERING FOR THE BENEFICIARIES OF THE CHARITY AS MAY FROM TIME TO TIME BE AGREED BETWEEN THE GOVERNORS AND THE GOVERNORS OF THE SCHOOL CONCERNED AFTER CONSULTATION WITH THE SAID AUTHORITY. (B) IN AWARDING TO BENEFICIARIES SCHOLARSHIPS, BURSARIES OR MAINTENANCE ALLOWANCES TENABLE AT ANY SCHOOL, UNIVERSITY OR OTHER PLACE OF LEARNING, APPROVED BY THE GOVERNORS; (C) IN ASSISTING BENEFICIARIES WHO ARE PREPARING FOR, ENTERING UPON OR ENGAGED IN ANY PROFESSION, TRADE, OCCUPATION OR SERVICE, BY PROVIDING THEM WITH OUTFITS, OR BY PAYING FEES, TRAVELLING OR MAINTENANCE EXPENSES, OR BY SUCH OTHER MEANS FOR THEIR ADVANCEMENT IN LIFE OR TO ENABLE THEM TO EARN THEIR LIVING AS THE GOVERNORS THINK FIT; (D) IN AWARDING SCHOLARSHIPS AND MAINTENANCE ALLOWANCES TO ENABLE BENEFICIARIES TO TRAVEL ABROAD TO PURSUE THEIR EDUCATION; (E) IN PROVIDING FINANCIAL ASSISTANCE TO ENABLE BENEFICIARIES TO STUDY MUSIC AND OTHER ARTS. (3) WITHIN THE LIMITS PRESCRIBED BY THIS SCHEME THE GOVERNORS SHALL HAVE FULL POWER TO MAKE RULES FOR THE AWARD OF SCHOLARSHIPS, EXHIBITIONS, BURSARIES, MAINTENANCE ALLOWANCES AND OTHER BENEFITS, INCLUDING RULES AS TO THE VALUE AND PERIOD OF TENURE OF THE AWARDS AND THE QUALIFICATIONS, METHOD OF ASCERTAINMENT AND SELECTION OF CANDIDATES FOR BENEFIT. (4) THE GOVERNORS SHALL HAVE REGARD TO THE DESIRABILITY OF CONSULTING THE LOCAL EDUCATION AUTHORITY AS TO THEIR GENERAL ACTION UNDER SECTIONS (B), (D) AND (E) OF SUB-CLAUSE (2) OF THIS CLAUSE AND, IF OCCASION REQUIRES, AS TO THE EDUCATIONAL QUALIFICATIONS OF CANDIDATES FOR BENEFIT. (5) IN THIS CLAUSE THE EXPRESSION "BENEFICIARIES" MEANS PERSONS UNDER THE AGE OF 25 YEARS WHO ARE IN NEED OF FINANCIAL ASSISTANCE AND WHO ARE EITHER RESIDENT IN THE AREA OF THE FORMER MUNICIPAL BOROUGH OF CHELMSFORD AND THE PARISHES ADJOINING THERETO OR ARE ATTENDING OR HAVE FOR NOT LESS THAN ONE YEAR AT ANY TIME ATTENDED A SCHOOL OR COLLEGE OF FURTHER EDUCATION IN THAT AREA.

**Activities:** The purpose of the Charity is to provide financial support to individuals under the age of 25 years and from schools and colleges within the former municipal borough of Chelmsford and parishes adjoining thereto, to further their education.

The Foundation is a charity, an unincorporated association, charity registration number 310799, of 5 Springfield Lyons Approach, Chelmsford CM2 5LB.

It is governed by a scheme sealed by the Charity Commissioners on the 11<sup>th</sup> day of September 1985.

**The Governors (Trustees) comprise:**

Mr A J Mitty, Mr M Minta, Ms R Connolly Mrs N Hiom, Ms A Feist, Mr M Iciek, Mrs A Davies, Mr A Ball and Cllr A McQuiggan.

The clerk is M Dorsett, Mrs K Sitara is Administrator.

The bankers are CAF Bank, Kings Hill, West Malling, Kent ME19 4JQ.

The solicitors are Gepp & Sons, 5 Springfield Lyons Approach, Chelmsford CM2 5LB.

The accountants responsible for examining the accounts are Richardson & Co Accountants, Cornish & Sussex Suite, House 3, Lynderswood Business Park, Black Notley CM77 8JT.

The stockbrokers are Investec Wealth & Investment, 2 Gresham Street, London.

Within the year Mrs Alison Davies was accepted as a trustee, resigning before the year end.

**The purpose of the Trust**

The purpose of the Trust is to provide financial support to individuals under the age of 25 years to further their education, and schools and colleges within the former municipal borough of Chelmsford and parishes adjoining thereto.

**Trust Assets**

The permanent endowment of the charity is held as stock exchange investments. The trustees will not spend the permanent endowment unless they have good reason so to do, and prior to any such expenditure will inform the Charity Commission of their decision and their reasons for making such a decision. Such expenditure is subject to the approval of the Charity Commission.

**The activities and achievements of the Trust**

The charity's income is derived from its permanent endowment and stock market investments.

A total of £30,200.91 was received in the current year. £23,293.87 was received in the year ended 30<sup>th</sup> September 2022.

Applications for grants are invited by advertising in schools and colleges in the qualifying districts. Details of the charity are also maintained on databases run by local organisations. Applications are considered by two sub committees who make recommendations to the governors who meet quarterly. In the current year £2,750 was paid to 3 individual applicants, compared with £10,900 to 8 individuals in year ended 30<sup>th</sup> September 2022. £7,000 was paid to schools in the current year, compared to £5,000 in the year to 30<sup>th</sup> September 2022.

**The accounts**

The charity's total income (excluding the sale of assets) is less than the small charity's threshold of £250,000 and a receipts and payments account has therefore been prepared.

The charity's assets have been invested in accordance with the powers available to the trustees.

The charity budgets to expend only its income and will not incur expenditure which is not covered by future income. In view of this policy, a specific reserve policy is not necessary, but the trustees will at all times be prudent in their expenditure.

The charity does not act as custodian for any other charity.

**Risk Assessment**


The trustees' primary risk is the loss in value of the charity's funds.

As a result of the sale of the charity's freehold property in 2012, the permanent endowment consists of stock exchange investments which are managed by the charity's stockbrokers. The trustees review the performance of the investments annually to monitor the performance of the stockbrokers.

The employment of a solicitor to administer the charity gives full protection from negligence or fraud both from the solicitor's indemnity insurance (£25 million limit) and the Law Society's indemnity fund.

The risk of misapplication of grants is low because grants are only given to well-known and solidly established local schools or to individual young people who are personally interviewed and means tested. References are always taken up.

The trustees have critically examined their conduct and consider that their conduct of the charity's affairs continues to be active and innovative and the risk of poor management is very low.


**Independent examiners' statement**




