(C) THE PROVISION OF ASSISTANCE FOR HIGHER, EDUCATION BY MEANS OF EXHIBITIONS TENABLE AT ANY PLACE OF HIGHER EDUCATION OR FURTHER (INCLUDING PROFESSIONAL OR TECHNICAL EDUCATION OR FINANCIAL HELP TO ENABLE BENEFICIARIES TO PREPARE FOR , OR THE ENTER, A PROFESSION, TRADE OR CALLING.(D) OTHERWISE PROMOTING THE EDUCATION (INCLUDING SOCIAL AND PHYSICAL TRAINING) OF BENEFICIARIES.

Activities: Makes grants to Church of England Schools in Offley and Cockernhoe. Gives financial assistance to persons of either sex, who are resident in Offley and who have not attained the age of 25 years; for outfits, clothing, tools, instruments or books in order to prepare for, or to enter, a profession, trade or calling.
