FURTHER INCOME, AGAIN NO MORE THAN ONE QUARTER CAN BE USED IN PROVING SPECIAL BENEFITS OF ANY KIND NOR NORMALLY PROVIDED BY THE LOCAL EDUCATION AUTHORITY FOR ANY MAINTAINED PRIMARY OR SECONDARY SCHOOL. INCOME MAY ALSO BE APPLIED IN AWARDING SCHOLARSHIPS, EXHIBITIONS, ALLOWANCES, GRANTS TENABLE AT ANY SECONDARY SCHOOL, COLLEGE OF EDUCATION OR UNIVERSITY AND PROVIDING FINANCIAL ASSISTANCE TO ALLOW BENEFICIARIES TO PURSUE THEIR EDUCATION OR ENTER A PROFESSION

**Activities:** The charity provides grants to young people who live in or were born in Charlton Kings and are under the age of 25. These grants are made for educational purposes - e.g. funding towards National Curriculum history trips, music lessons, activities associated with Guiding and Scouting (such as international gatherings), support for university or college education.
