THE NAME OF THE SOCIETY'S BOOK CLUB SHALL BE THE LOCAL POPULATION HISTORY BOOK CLUB; (V) PUBLISH A JOURNAL CALLED LOCAL POPULATION STUDIES AND OTHER OCCASIONAL PUBLICATIONS REPORTING THE RESULTS OF SUCH RESEARCH.

Activities: Promotes the study of local historical demography and associated topics by promoting education and research in these fields. Publishes the journal 'Local Population Studies' and other occasional publications, and organises conferences for members and wider audiences. Offers a book club to encourage the reading of material relevant to local historical demography.
