**Objects:** (A) THE ADVANCEMENT OF EDUCATION AND IN PARTICULAR BUT WITHOUT PREJUDICE TO THE GENERALITY OF THIS OBJECT THE PROMOTION ENCOURAGEMENT AND GIVING OF ASSISTANCE TO: (I) NEW AND DIFFERENT APPROACHES TO EDUCATION; (II) EDUCATION WHICH IS ESPECIALLY CONCERNED TO ACHIEVE THE GROWTH OF THE WHOLE PERSON BY BALANCED SPIRITUAL MORAL MENTAL AND PHYSICAL DEVELOPMENT; (III) EDUCATION IN THE HISTORY OF LANGUAGES LITERATURE INSTITUTIONS AND CULTURE OF DIFFERENT RACES NATIONS AND SOCIAL GROUPS; (IV) EDUCATION WHICH MAKES NO DISTINCTION BETWEEN THE MEMBERS OF DIFFERENT RACES NATIONS AND SOCIAL GROUPS (V) EDUCATION IN ACCORDANCE WITH THE SPIRIT OF THE TEACHINGS OF JIDDHU KRISHNAMURTI; (VI) THE EDUCATION OF INDIVIDUALS REQUIRING FINANCIAL SUPPORT IN DEVELOPED AND DEVELOPING COUNTRIES OF THE WORLD. (B) THE PROTECTION OF HEALTH AND IN PARTICULAR BUT WITHOUT PREDJUDICE TO THE GENERALITY OF THIS OBJECT THE GIVING OF FINANCIAL ASSISTANCE TO SUCH HOSPITALS CLINICS AND DISPENSARIES AS ARE NOT RUN FOR PRIVATE PROFIT. (C) TO RELIEVE POVERTY AND SICKNESS (WHEREVER IN THE WORLD THEY MAY OCCASIONED) BY THE PROVISION OF GRANTS AND BY THE GIVING OF ASSISTANCE TO PROJECTS DESIGNED AND CALCULATED TO ACHIEVE SUCH RELIEF.
