IV) TO PROTECT PLACES AND OBJECTS OF ENTOMOLOGICAL BOTANICAL ZOOLOGICAL OR ECOLOGICAL INTEREST FROM INJURY ILL TREATMENT OR DESTRUCTION. V) TO PROMOTE THE EDUCATION OF THE PUBLIC IN ALL MATTERS NECESSARY FOR THE PROTECTION AND PRESERVATION OF THE NATIONAL HERITAGE.
