The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

OBJECTIVES AND ACTIVITIES

The Welsh Council on Alcohol and Other Drugs (the Council) is a Registered Charity (no 501658) established “to advance the education of the public in the benefits of promoting a lifestyle free from substance misuse; to provide support to those who suffer in any way as a result of their substance misuse, in particular, but not exclusively, women and children, who, as a result of criminal behaviors, are in conditions of mental and/or physical distress; to preserve and protect the good health of the public by the provision of advisory and counselling services”.

The trustees will hope to amend these charitable Objectives & Aims in their AGM on 29th January 2025.

Proposed amendments to Charitable objects

- (1) To advance the education of the public in the benefits of promoting a lifestyle free from substance misuse and maladaptive behaviours
- (2) To provide support to those who suffer in any way as a result of the impact of substance misuse and maladaptive behaviours, in particular but not exclusively, partners, families, and friends who, as a result of these behaviours, are in conditions of mental and/or physical distress
- (3) To preserve and protect the good health of the public by the provision of counselling services, ongoing support and aftercare.

Area of benefit = Wales. Suggested NATIONAL AND OVERSEAS.

The charity has been dormant for some years. Recently, a renewed vision has been sought to apply and promote its objectives in the current digital age. To that end, current trustees are investigating new projects to realise its objectives and exploring new funding avenues.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The governance structure is that of a Board of Trustees – who, together with a Company Secretary, manage the Charity's Strategic direction and policies. Board attendance comprises the chair person, company secretary and the Trustees, which are elected - re-elected at Annual General Meetings.

INDUCTION & TRAINING

Trustees are invited to receive training which allows them to carry out their duties with the benefit of understanding.


