Governing document

The charity is operated under the rules of its original Constitution dated 23rd September 1952, as amended by the resolutions on 2nd November 1994, 18th July 2000, and 23rd September 2008. The management of the charity is the responsibility of the Trustees, who are elected and co-opted under the terms of the Constitution. There are no paid staff.

Objectives

The principal objective of the charity is to promote the relief of elderly people in any manner, which now or hereafter may be deemed by law to be charitable in and around the parish of Warsop.

Activities

The charity has 2 principal activities based together in Warsop. The first is a drop-in centre that provides light refreshments and an opportunity for people to socialise. The second is a charity shop selling donated goods to the public.

The charity also organises coach outings. These are run primarily for elderly residents from the Warsop area, but not exclusively. They provide day trips out to locations across the country, and are a useful opportunity for people to get out and meet others.

All activities are organised and supervised by Trustees and other volunteers. The charity had 20 volunteers available to them during the year (15 in the previous year during the worst of the COVID-19 pandemic).

The Trustees confirm that they have complied with the duty in section 4 of the Charities Act 2006 to have due regard to the Charity Commission's general guidance on Public Benefit, 'Charities and Public Benefit'.

Summary of the main achievements of the charity during the year

Operations were reduced during the first half of the year, due to Government restrictions in the light of the COVID-19 pandemic. Although the drop-in centre and charity shop were open whenever national rules allowed.

Activities fully opened from October 2021. At this time the Trustees reluctantly took the decision to close the separate charity shop as it was no longer viable. Instead, they moved that operation into the existing building on the High Street, to act as an ancillary activity to the existing drop-in centre. Each one attracts customers, so there is plenty of crossover. This move has proved successful.

The external coach outings are still very popular with our supporters, the charity runs at least 8 per year and they are self-financing.

The charity has a program of building repairs and improvements, which continued during 2021.

The charity's policy on reserves

The charity's policy on reserves is to have sufficient funds available to meet at least twelve months of running costs. This measure allows the charity to continue to plan its programme of building repairs, re-decoration, and replacement of equipment. It also provides a reserve to cover other unforeseen costs that may arise in the future. The reserves policy is currently being met.
