# THE FRIENDS OF THE HERFORD THREE CHOIRS FESTIVAL

## ANNUAL REPORT

YEAR ENDED 31 OCTOBER 2022

The Friends continue to support the Herford Chamber Choir's Choral Scholarship scheme, sponsoring 3 young choral scholars, age 17 to 19, to attend weekly rehearsal and concerts with the choir.

In December 2021, we held a Quiz evening in the delightful setting of Lyde Arundel, Herford. Our quizmaster, Lord Lisvane, devised some wonderful questions and kept us all entertained whilst the Friends provided interval cheese and wine. The evening was well attended and raised over £1100. In March, we gathered in Holy Trinity Church for a Song Recital by the soprano Lucy Bowen. She gave a stunning performance of music throughout the centuries which contributed another £1000 towards our funds.

Unfortunately, our annual members' tea which was to be held later in March, had to be cancelled due to a local outbreak of Covid. We look forward to being able to stage this again in 2023. Sadly, illness also led to the cancellation of the Song recital planned with soprano Rachel Roper at Hellens House. Rachel was suffering with a throat infection and so, regrettably, we were forced to cancel the evening.

Despite the uncertainties created by Covid, preparations for the 2022 Festival went ahead as usual, albeit with the increasing demands of heightened legislation and due diligence.

For the first time we had to take out our own Public Liability Insurance, at a premium of £622.81. Previously, we had come under the umbrella of the main festival foundation, but this is no longer the case and therefore a necessary extra expenditure for us.

October 2021 saw the introduction of Natasha's Law, requiring clear labelling and allergen information on packaged food and detailed record keeping of allergens in all foods supplied. This meant that we needed to employ a professional chef and team to assist us, printing detailed sandwich labels and keeping careful note of all allergens in the foods prepared, such as for the daily evening Hot Suppers, sandwiches and salads and ensuring that we complied with legislation at all times; a necessary, but costly process.

Two of our key café team leaders completed a Food Allergy and Intolerance Training course and First Aid course, whilst 6 team leaders completed the Level 2 Food Safety and Hygiene Course. Aside from the financial support, we take great pride in extending a warm welcome to all, and when the festival chorus met for their massed rehearsals in Herford, we provided the eagerly anticipated refreshments, always greatly appreciated by the volunteer chorus.

In spite of worries about the effects of Covid, our loyal band of around 100 volunteers turned out in force to assist and welcome visitors over the 8 day period of the Herford Three Choirs Festival. Our teams ran the Sports Hall café, providing an ongoing buffet from 11am to 7.30pm. Football was slightly down on previous years. The signal for the card readers proved very fickle, an issue that needs addressing next time.

We hosted an Art exhibition in the Sports Hall, receiving a welcome percentage of the sales. Sandwich teams provided for both Sports Hall and Zimmerman cafes and as the week progressed, we were also asked to provide sandwiches for the Festival Bar on the cathedral close, where post-concert attendees were requesting food. This additional order brought in a very welcome, unplanned, additional £910 for the Friends.

Our Zimm café teams provided hot and cold snacks from 9am to 6pm and often later, to the public, chorus and orchestra. The chorus received complementary tea and coffee. There was good football and a very lively atmosphere. We ordered ice cream from a local supplier, which, along with bottled water, our volunteers sold in the cafes and during evening concert intervals.

We ran the Festival Information Point, where we also sold draw tickets for our raffle.

We set up a Quiet Room for patrons, providing comfy chairs and daily newspapers.

We provided drinks and pastries for the breakfast talks and members' forum in St Johns Methodist Church, for which we were reimbursed by the main festival association.

Pre-booked Hot suppers were held in the school dining room each evening. These consisted of 2 courses plus a glass of wine, cooked by school chef Chris Prosser and his team, with additional puddings provided by an outside caterer, Christine's Catering. Friends' volunteers were on hand to welcome and serve the guests. Sadly, numbers were substantially down this year, possibly due to increased choice of venues in the city or relating to the evening concert programme, or Covid anxieties. Discussions to be had for next time.

The Friends obtained sponsorship for, and then assembly of, beautiful floral displays across all our sites and within the cathedral and worked incredibly hard throughout the week maintaining these.

We hosted two paying ticketed events during the week; the *Opening Reception* and the *Garden Party*. We welcomed over 100 people to the Opening Reception, with 3 of our members sponsoring the fizz and canapes. Unfortunately, the numbers for the Garden Party were down on 2018, resulting in very little profit, although much enjoyed by those present.

Our fundraising facilitates sponsorship of an evening cathedral concert, which this year was a stunning performance of Haydn's *Creation*, sung by the combined Three Cathedral Choirs. The concert was dedicated to former Friends' member, Elizabeth Bennett, in recognition of her generous bequest in 2019.

Following the Festival we held our usual 'thank you' party in September for all our volunteers, providing refreshments and nibbles.

Although the Festival was well received by volunteers and patrons alike, Covid, increased food costs and above all, the necessary labour costs, took a heavy toll, resulting in a greatly reduced net profit overall compared with previous years. We still have sufficient funds at present, but have to recognize the increasing pressures on our committee to raise the desired triannual £30000 financial support for the Hereford festival. Mindful of this we shall maintain ongoing discussions with the main festival 3 Choirs Foundation to devise the best way forward in 2023.
