

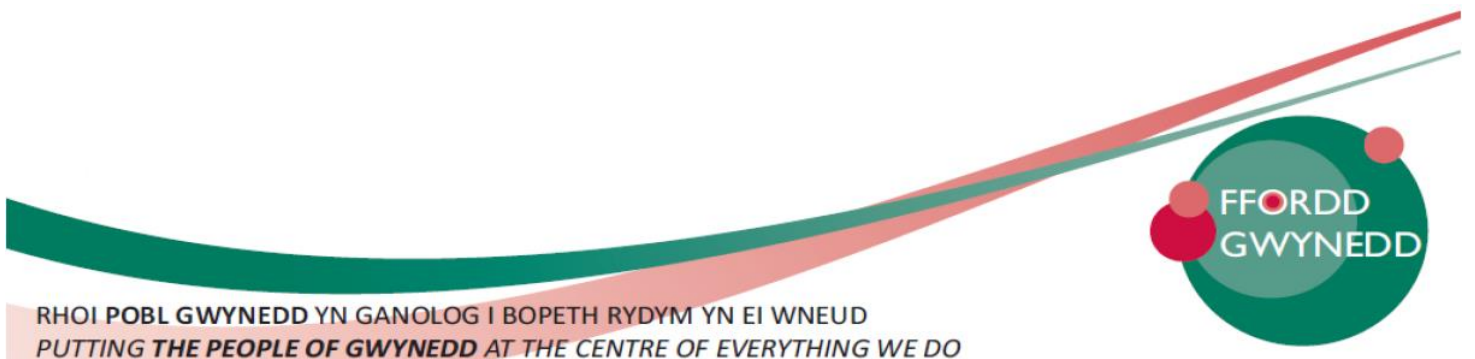

1. Cefndir

- 1.1 Mae Amgueddfa Lloyd George a chartref ei blentyndod, Highgate, Llanystumdwy, yn olrhain bywyd cyn Brîf Weinidog Prydain. Gweinyddir yr amgueddfa, sy'n elusen gofrestredig, gan Gyngor Gwynedd gyda chymorth Cyfeillion yr Amgueddfa sy'n cefnogi a chynorthwyo datblygiad yr Amgueddfa a'i defnydd addysgiadol. Oherwydd bod yr elusen wedi uchafu trothwy incwm o £25,000, rhaid cyflwyno cyfrifon ac adroddiad blynyddol yr ymddiriedolwyr i'r Comisiwn Elusennau am 2020-21, gan gynnwys adroddiad archwiliwr annibynnol o'r cyfrifon.

2. Bwriad a Chwmpas yr Archwiliad

- 2.1 Bwriad yr archwiliad oedd cwblhau adroddiad archwiliwr annibynnol o gyfrifon yr Amgueddfa am y flwyddyn ariannol 2020-21, gan roi sicrwydd bod yr hyn a gyflwynir i'r Comisiwn Elusennau yn gywir. Gwnaethpwyd hyn drwy eu cysoni gyda chyfriflyfr y Cyngor, gan sicrhau bod yr holl drafodion yn berthnasol i'r Amgueddfa.

4. Prif Ddarganfyddiadau

- 4.1 Yn dilyn penderfyniad y Cyngor i roi'r gorau i redeg Amgueddfa Lloyd George o 1 Ebrill 2017, fe gyhoeddodd Llywodraeth y DU y byddai'r bwlch ariannol blynyddol o £27,000 yn cael ei gyfarch gan Lywodraeth y DU am 3 mlynedd hyd at 31 Mawrth 2020. Yng nghyfarfod o'r Cabinet ym mis Rhagfyr 2019, penderfynwyd yn ei rôl fel Awdurdod Lleol i gyfrannu £27,000 ar gyfer 2020-21 o Gronfa Drawsffurfio'r Cyngor er mwyn caniatáu mwy o amser i'r Ymddiriedolwyr, sef y Cabinet mewn rôl ar wahân, ystyried modelau gorau ar gyfer y dyfodol. Wrth gwrs, cafodd COVID-19 effaith sylweddol na ragwelwyd ar yr amgueddfa, ac ar y 12/01/21 gofynnwyd i Gabinet Cyngor Gwynedd i wneud cyfraniad un tro am gostau blwyddyn yr amgueddfa am 2021-22 er mwyn prynu rhagor o amser. Trafodwyd sefyllfa ac opsiynau ar gyfer rheolaeth yr elusen yn nghyfarfod y Cabinet – yn eistedd fel Ymddiriedolwyr yr elusen – ar 14/09/21.
- 4.2 Darganfuwyd fod y cyfrifon ar gyfer 2020-21 yn briodol ac felly cwblhawyd adroddiad yr archwiliwr annibynnol er mwyn datgan hynny.
