### **TRUSTEES REPORT**

#### **Governance**

The Charity operates under the rules laid down in its *Trust Deed*. Work to modernise the Trust Deed commenced in 2018 based on guidance from ACRE (Action with Rural Communities in England) but is incomplete but is still working towards. Furthermore, the current Charity is unincorporated which leaves Trustees exposed to unlimited liability. Work is underway to complete the formal legal process for changing to a Charitable Incorporated Trust which would also provide a modern Constitution for the conduct of business and ensure compliance with the Charities Act 2011.

#### **Trustees and Management**

*The Committee of Management consists of 5 members elected at the AGM and 4 nominated Trustees but may not include more than 2 co-opted members.*

Two Trustees joined the Committee during the year, one leaving within the same year leaving vacancies for an elected member, and two co-opted members.

The Hall has the services of a self-employed Manager, and self-employed weekday and weekend cleaner and are fortunate to have the services of numbers of volunteers who have saved the village hall a considerable amount in routine maintenance and gardening costs.

#### **Objects**

The objects of the Charity are: *"to hold in trust the village hall for the use of the inhabitants of the Parish of Scotton, North Yorkshire without distinction of political, religious or other opinions, including use for meetings, lectures, classes and other forms of recreation and leisure time occupation, with the object of improving the conditions of the life of the said inhabitants". Trust Deed, 15<sup>th</sup> May 1975*

#### **Activities**

The Trustees have met regularly to ensure the good governance of the Charity. There have been five (5) full Trustee meetings and eight (8) management meetings since the last AGM. The activities of the Charity have been very limited due to the Covid Pandemic. We were able to let the Hall for short periods to groups: the art group; badminton clubs; bowling club; dancing club; guitar club; music group; Parish Council and Pilates. There was one new regular booking for dog obedience classes. So with the loss of many of the classes, booking took a nose dive giving minimum occupancy.

The rules applying to the Covid restrictions have been removed by the government and this has allowed us to open on a regular basis to those who wish to use the facility. We have tried to maintain good practice in relation to Covid in asking those using the Hall to maintain as far as possible the requests made by government since restrictions have been lifted in relation to the pandemic.

It was agreed at the beginning of the pandemic not to have any ad hoc hiring of the Hall as the risk to users and volunteers would have been too great. With the total lifting of the restrictions we have recently started to have more ad hoc bookings but still not as many as pre pandemic. There has been more interest in using the facility on an ad-hoc basis and we are beginning to see booking improve.

Our regular hirer's have indicated to us that they are having difficulties themselves with the number of attendees at their meetings that they may reduce the number of times they need the hall. This is something we need to be attentive of for future financing.

### **Public Benefit**

The Trustees have regard to the Charity Commission guidance on *public benefit* and the income from regular bookings and those from further afield enables discounts to be given to event bookings from within the Parish of Scotton and Lingerfield (we were able to enable some community events to be free of charge) and for charity fundraising events. During the year there were no bookings from the village, from the Parish Council or the primary school that we have not been able to accommodate. It has been indicated to us that there may be an increase in the demand from these bodies to start using the Hall in the future.

### **Achievements**

During the year the various opening and closing due to the pandemic has necessitated a lot of work in controlling expenditure and applying for grant support from our local authority. This has been approached actively and we are in a secure position, currently, with monies still in the bank. We have taken every opportunity to obtain funding from government sources when these have become available throughout the year and have been successful in every application we have made. We are aware of our responsibilities to spend the grant monies as they have been issued and intended for.

During the year work has been ongoing in relation to the change of status to a Charitable Incorporated Organisation. Meetings have been held with Solicitors, Greenwoods, to agree the suitability of a new Constitution for a CIO. This was approved by the Trustees, and we are in the process of getting approval from the area of benefit before submitting to the Charity Commission. This work has continued with the support of the Community First Yorkshire organisation, and it is hoped to complete the transition to Charitable Incorporated Organisation in 2022.

### **Future Improvements**

Due to the closures works we highlighted last year have been put on hold until our finances are on a more even keel. These include but are not exhaustive, the erection of lighting bollards (for which ducts have already been laid) around the car park perimeter to improve safety and security. Replacement of the poor-quality hedge to the right of the car park entrance with a beech hedge to compliment that along the southern boundary; and the laying of permeable membrane and covering with slate or aggregate along the sides of the car park which will be a low maintenance solution to the suppression of grass and weed growth. We are trying to create a sustainability plan for the Hall ongoing.

The Committee continue to look at ways to promote greater use of the hall by the village. In the light of the success of previous events for the village, we hope to organise more that will enhance the availability of the Hall for use by those in the area of benefit.

## **Finances**

As an unincorporated charity the only fixed asset, the hall and surrounding land, is currently held by the Charity Commission as Custodian Trustees.

Annual accounts show that total expenditure for 2021/22 was £18,522 (£7,634 in 2020/21) supported by COVID grants paid by Harrogate Borough Council totalling £12,267.

At 31<sup>st</sup> March 2022 assets (other than land and buildings) totalled £39,532 (£30,081 in 2020/21). The Charity's total income for 2021/22 including grants was £27,973 (£23,429 in 2020/21) and its annual running and maintenance costs were £18,522 (£7,634 in 2020/21) leaving a surplus of £9,451 taken to reserves (2020/21 surplus £15,795). Reserves will need to be sufficient to enable the final phase planned exterior works and the proposed constitutional change to be undertaken. The hall was re-valued in 2021/22 to ensure it is insured sufficient to cover any liabilities and will be reviewed in five years.
