Basis of independent examiners' report

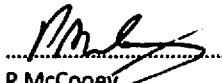

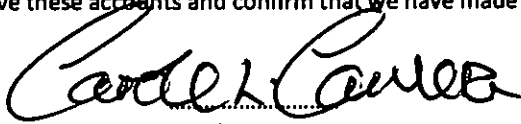
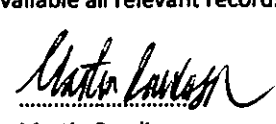
